#### Membership Meeting - June 18, 1981 - 12:30-2:30 pm.

Darlene Bailey announced that the University Health and Safety Committee needed more membership participation and suggested that two members from each of the major buildings occupied by AUCE members be elected to stand on a subcommittee in order to create a more viable communication link with the members. # 1. Adoption of agenda:

Nominations were opened for the Contract Committee (Section 5A). The Provincial Education Committee was a standing committee and would remain under closing nominations until positions were filled. Nominations were opened for alternate delegates to the Convention which would reconvene on Saturday, June 27th. Nominations were opened for a Provincial Representative. Contract representatives would also be required for each division. Nominations were opened for the strike committee.

### 2. Adoption of minutes:

As the minutes in the May newsletter had not been adopted at the May meeting, a motion to adopt was considered to be in order.

She felt that due to the complexity of the tasks and the high level of responsibility, people interested in assuming salaried positions should gain experience and become familiar with ongoing issues by participation in various committees which are wide open for activity. Questions arose as to the interpretation of the second motion on page 14 of the June newsletter. The phrase "to negotiate" was intended to have been "to look into strategies on".

## 3. Business Arising from the Minutes:

Nancy Wiggs spoke briefly on the activities of the Convention. A discipline clause was called up. A charge against Local 5 on the CCU affiliation issue was read out. The charge would be incorporated into a motion and if passed, a telegramme would be sent to Local 5 informing them of the charge.

With regard to the per capita tax arrears owed by Local One, Nancy suggested that, in order to clean up our act, that we request a grant from the Provincial which would be used to pay off the debt and therefore settle the affair.

Moved by Nancy Wiggs Seconded by Pat House THAT THE MEMBERSHIP SUPPORT THE FOLLOWING CHARGE AGAINST LOCAL FIVE: AUCE LOCAL ONE HEREBY CHARGES AUCE LOCAL FIVE UNDER SECTION 19(F) OF THE PROVINCIAL CONSTITUTION IN THAT IT AFFILIATED TO THE CANADIAN CONFEDERATION OF UNIONS IN CONTRAVENTION OF AUCE'S POLICY DECISION TO AFFILIATE INTACT TO THE CANADIAN LABOUR CONGRESS. FURTHER, IT IS THE POSITION OF AUCE LOCAL ONE THAT A REPRIMAND IS TOTALLY INADEQUATE AND INAPPROPRIATE GIVEN THE SEVERITY OF THE SITUATION. WE URGE THAT A HEARING BE HELD ON THE MATTER AS SOON AS POSSIBLE. Minutes - Membership Meeting - June 18, 1981 - Page Two

Sheila Rowswell asked for an explanation of the disciplinary clause to which Nancy referred. Nancy explained that one Local can lay a charge against another local. Ten days notice must be given for a hearing scheduled by the Provincial Executive. If a decision to suspend or expel is reached, a special convention will be held to present this information.

- Alternate Delegates Ted Byrne, Irene MacIntyre, Wendy Lymer, Sharon Newman and Cheryl Jolliffe were nominated. Ted, Irene, and Wendy accepted.

A letter from the Concerned Citizens for Choice on Abortion (CCCA) asked that three motions be presented to the membership

Moved by Wendy Lymer Seconded by Pat House THAT AUCE LOCAL ONE RE-ENDORSE CONCERNED CITIZENS FOR CHOICE ON ABORTION AND ITS AIMS: DEFEND A WOMAN'S RIGHT TO CHOOSE AND REPEAL ALL ANTI-ABORTION LAWS.

A member asked if we have supported this group in the past. Nancy Wiggs responded that AUCE Local #1 has offered its support for the last two years. The CCCA directs its activities at protecting the right of all women, at preventing Pro-Life individuals from taking over hospital facilities and its policies are concerned with equality for women.

The motion was CARRIED.

Moved by Wendy Lymer THAT AUCE LOCAL ONE ENDORSE THE 1981 MARCH AND RALLY FOR Seconded by Nancy Wiggs REPEAL.

The motion was CARRIED.

Moved by Wendy LymerTHAT AUCE LOCAL ONE SEND A CONTINGENT OF MEMBERS AND ASeconded by Nancy WiggsBANNER TO THE SEPTEMBER 12 DEMONSTRATION.

The motion was CARRIED.

Helen Glavina and Nancy Wiggs offered to participate in the demonstration.

7. Grievance Committee (Pat House):

Two major concerns to report:

- 1. Jane Strudwick supported the idea that the employer could place reports in employee files without notifying the employee. A Labour Committee hearing ruled in AUCE's favour.
- 2. The Computer Operator proposal has been implemented by the University. The Grievance Committee has started a policy grievance as a result. The University is in contravention of Article 31.01. A Labour Committee meeting will be held on July 6th to discuss the problem.

#### 8. Executive Report (Suzan Zagar):

CUPE is negotiating with the University. Their contract expired on March 31, 1981. We should be prepared for possible strike action. It is highly unlikely that CUPE will settle for what we settled for at the signing of our last contract. Strike action might occur in August or September.

Suzan then referred to a notice of a proposed by-law change which was printed on page ten.

Moved by Nancy Wiggs Seconded by Sheila Rowswell THAT THE PROPOSED AMENDMENTS TO SECTION E OF THE BY-LAWS BE ADOPTED AS CIRCULATED.

Helen Glavina said that the Executive felt that the Job Evaluation Committee and the Working Conditions Committee are becoming extremely important to the function of the Executive.

The motion was CARRIED.

## 9. Job Evaluation Committee report (Elizabeth Brock):

Elizabeth indicated that there **woul**d not be a report at this time. Russ Selinger drew attention to the notice of motion on page 10 of the newsletter which would be introduced at the next meeting.

## 10. Provincial report (Sheila Rowswell):

- At the Convention, the Provincial was faced with the problem of what to do about Local 5 which has affiliated with the CCU. An amendment to the discipline clause in the Provincial Constitution was passed. The general feeling was that a reprimand was in order but the delegates at the Convention were divided as to the form. The per capita tax owing from Local One was also discussed. A motion was made by Local 6 in an attempt to resolve the issue. The matter was referred to a subcommittee which has not yet reported back. The special assessment for the benefit of Local One is still being held in trust until **all locals** have contributed. Thus far, \$4,300 has been collected. The total amount will be \$5,887.
- The Provincial has had problems with a lack of staff due to several resignations. It has become difficult to realize many goals. The library at the Provincial Office is open to all members. There is a fair amount of information available on labour management and contract negotiations.

- A Provincial Executive subcommittee has been set up to lobby the CLC to admit AUCE intact. Although this subcommittee has spoken to quite a few members of the CLC, the matter will remain up in the air until the CLC Convention next year.
- The Provincial budget will be discussed this weekend when the AUCE Convention delegates will reconvene at a location yet to be announced. Members wishing to observe the proceedings are very welcome.
- Nominations for Provincial Table Officers are still open but will close on the last day of the Convention. Nominated for President are Bob Wiseman, Anne Sullivan, and Bob McAdie. Nominees for Vice-President are Jack Gegenberg, Nancy Wiggs, and Star Rosenthal. Nominated for Union Organizer (a potential paid position) are Sheila Perret, Lauma Evans and Bob Wiseman. Lid Strand has been nominated for the Secretary-Treasurer position.
- A member of the Canadian Farmworker's Union was an invited speaker. A motion was made to support their picket lines and a donation of \$500 was offered. Representatives from the Central American Support Committee and the Canadian Institute Educators Association were also guest speakers. A member of the B.C. Student's Federation was also expected to give a brief report.
- Nancy Wiggs urged members to consider running for positions on the Provincial Executive as there has been an inconsistent representation of Local One at Provincial meetings. She added that it was a good avenue to learning more about the workings of our union by participating in such a vital area.
- Ray Galbraith asked what had happened with regard to Local 4 at the Convention. Sheila Rowswell responded that Local 4 introduced a motion pertaining to Local 5's affiliation with the CCU; a short time later, the Local 4 delegates left the Convention Hall.
- Lissett Nelson stated that AUCE was not intact anymore and therefore the slogan "Lobby intact" was not feasible. Nancy Wiggs commented that the Local 4 delegates were instructed by their membership not to stay at a Convention which has been infiltrated by the CCU. Further action by Local 4 will be discussed at a later meeting. They would be in touch with us as to the results.

Suzan Zagar entertained a motion to adjourn the meeting.

Moved by Murray Adams THAT THE MEETING BE ADJOURNED. Seconded by Nancy Wiggs

The motion was CARRIED.
