# linutes of the Provincial Executive meetings February 9th & 11th, 1980

# .. Local reports -

Local 5 - Ron Faktor reported that next memberhsip meeting was scheduled scheduled to take place on February 20th. The negotiating team has been elected by the membership - Vicki Nunweiler and Kathy Parker they need lots of help with research from other local contract committees. Jenny Somero is still meeting with managment on job evaluations, the end is not in sight. Management has arbitrarily excluded a position from the bargaining unit - bookstore manager. The similarity between this situation at Locals 4 & 5 regarding the exclusion of this position from the bargaining unit was discussed. The local was encouraged to grieve such attempts by management to erode the bargaining unit. Provincial has scheduled the Labour Canada-funded educational week-end for the 21st, 22nd and 23rd of March. Topics for the agenda are ContractInterpretation, Shop Steward responsibilities, Grievance and Arbitration procedures.

Local 6 - Mary Mabin reported that negotiations are still underway. The Ad-Hoc (anti-TSSU) committee has told #6 that they have sent a letter to the LRB in complaint of TSSU failure to represent the majority of the bargaining unit - this was found out to be a lie. Local 6 has hired two workers to do organising - Louise Normandin and Nick Coleman. SFU has made a wage offer which they claim to be worth a 17% average increase - they've yet to prove this. #6 wants a COLA clause; the University has refused. 265 people are now signed up.

Local 1 - reported by Lid Strand that negotiations are well underway. The present contract expires on March 31st, 1980. The membership has voted to demand a 17% wage increase. The University has yet to come up with an offer and says they will do so after all union demands are on the table. Local 1 is working to revise the penstion plan to make it voluntary and that eligibility is optional depedning on the age of the employee and the length of service at UBC. Elections are coming up. The local Affiliation meeting for the membership is planned for March 6th at lunchtime; Lisset, Helen, Jet and Lid are planning this meeting.

Local 4 - Anne Gilbert reported that a couple of grievances have been filed on hiring and promotion where an employee with seniority was rejected for a job vacancy. The local has restructured the steward system and has a problem getting people to volunteer to be stewards; steward training would be great for this local. Youth Employment Programs and Work-Study Programs proposals are being discussed and negotiated by management and the union. The college is in the final stages of hiring a new Personnel Director.

Local 2 - reported by Hester Vair and Joan Wood that local executive elections are coming up for nominations in early March. Joan and Hester got their job split after threatening to file a grievance. The LRB hearings on the 'grandfathers' complaint vis à vis appropriation of earnings for strike funds has not yet finished and is scheduled to resume in March. Negotiations for the IIC left-overs, the O's and 1's are still going on - no indication when this item will be finalised.

- Tabled motion (item 4 above) was discussed. CARRIED with one abstention. The meeting discussed the Special General Membership meeting, below are SOME comments:

LS: At Local 1 the notices were sent to the stewards who posted them.

- Discussion on Special General Membership meeting continued: 7. MM: If I were rank and file in #6 I wouldn't have known.
  - AG: Local 4 was very well informed
  - SR: Seemed to be no enthusiasm at #2 about the meeting.
  - JW: Provincial events in general are not something which interests the locals, it seems. At Local 2 the Executive, people don't know about Provincial, they don't think it does anything, they resent it ...
  - LS: Acouple of years ago a cross-local steward meeting would be well attended, it was O.K.
  - SR: Our local meetings are well attended because they happen during lunch hour; people have their lives to lead on a Saturday.
  - LS: Same thing in Local 1 night-time mtgs don't work.
  - HV: The tape will be really good info.
  - JW: People did really good jobs at the meeting.
- 8. Bulletins discussed plan for getting the rest of them out. Ron is taking a batch to Local 5; Ginny and Carol will take #4's out; Mary has sufficient for #6; #1's will go out first of the week as will #2's.
- 8. SFU 18 report:

Attorney-General, Allan Williams, has refused the delegations request to have the convictions overturned and the remaining charges dropped.

Moved by Lid Strand and Seconded by Susan Knutson that AUCE Provincial responds to Allan Williams decision and condemn his refusal to have the charges dropped, with a copy sent to the SFU 18 and media. CARRIED

Susan Knutson reported on the defense progress.

9. Workers Compensation Board - BC Fed objection to non-affiliate appointment. Mary Mabin moved and Seconded by Lid Strand that AUCE Provincial responds to the BC Fed objection, as an independent union not as a CCU supporter.

CARRIED copy to be sent to CCU & WCB appointee.

10. Planned Parenthood funding cut; Muckamuck; Makara (from Correspondence) Moved by Lid Strand and Seconded by Mary Mabin that AUCE Provincial issue a press release condemning Federal gov't funding cut of Planned Parenthood budget. CARRIED

Moved by Mary Mabin and Seconded by Lid Strand that \$50 be donated to Planned Parenthood.

Moved and Seconded that This item be referred to the table officers for availability of money in Donations budget. CARRIED

Moved by Lid Strand and Seconded by that AUCE provincial donate to the Muckamuck Strike Fund and that the Table Officers allocate the amount which shall not exceed \$150.00 CARRIED

Convention stated that only lost wages would be paid for. Some members stated that they felt it was important to give work to those members who have no income due to lay-offs, temporary hires, etc.
