#### Notes on Pentacare Day Care Centre

The daycare centre is to be located where the rehab people are presently (they are moving to a new building in April). The university has donated the building, and apparently the services as well, although nothing definite has been said. The centre will accommodate 25 children, providing both daycare and kindergarten services. The decision to limit the centre to 5 year olds is that they are more constructive in their play and younger children frustrate them. There is a demand for at least 50 places right now (results of a survey they completed).

This centre would be open to all people in the university community; staff, students, faculty. The government has limited the amount they can collect per month per child to \$120, 80% of which covers staff. Each parent with a child using the centre must participate for at least 1 1/2 hours per week with a monthly work party.

This is their first daycare centre. They have applied to several sources for funding, including the government. Money is tight right now and they are not hopeful of substantial support from the government. They have also applied to CUPE and the Graduating Class. AUCE is the only organization to respond to their letters.

The money required is for renovations and equipment purchases. They feel they would need \$15,000-\$18,000 to start up and will provide a breakdown of this amount to us.

The group is hoping for an early summer opening but Wally Hutcheson feels a September opening is more realistic.
