The Local membership refused to endorse the Executive's handling of the situation and the feeling of the membership seems to be that, if the Executive believed Marcel Dionne had violated the Constitution, By-Laws or a membership decision, then the proper procedure would have been to charge him formally, as is provided for in the Constitution (re-call). No one seems to want to press charges. Nancy Wiggs had been Local 1 President during the interim. Membership meetings are getting a bare quorum at this time of the year. Suzan reminded the Provincial Executive of the Local Executive's position on the increase amount of the per capita tax; i.e. that they do not want it to be applicable to August, and, if and when a dues referendum is held in the Local and it passes, then they will commence paying the \$1.25 difference starting that month. The Local Executive has stated that the subject of paying the difference between August and the month the Local dues increase takes effect, is another question, which will be addressed 'when the time comes'. At this point during the discussion, it was pointed out that, if the dues are not up to date, because they have not been fully paid, then, according to the Constitution, the following is effective:
 - dues are in arrears past 90 days

- Local 1 members are no longer in good standing

- Local 1 members cannot vote in referendums until the dues is up-to-date
- Local Reps, Suzan Zagar & Kitti Cheema cannot vote at Provincial Executive meetings.

- Lid Strand, as member of Local 1, cannot chair the Provincial Executive meetings, as Provincial President

- it was noted that the Executive and NOT the membership has made the decision to withhold the dues increase portion that is in arrears.
