Sheila Perret gave notice that all outstanding minutes from the May and June 1981 meetings, and the 1981 Annual Convention Minutes, will be presented to the September meeting of the AUCE Executive, for adoption.

3. Local Reports

Liz Brock had prepared a report which she read, and the report was supplemented by further news from Liz & Sheila Rowswell. See Appendix 'A' for the written report. In addition, at the recent meeting of the Local membership, a voted was passed that approved the expenditure of \$3900 to supplement a \$900 grant from Labour Canada, in order to conduct research into the impact of microtechnology (word-processors, video display terminals, etc.) at the UBC campus. The major concern with the increasing use of micro-electronics at UBC is the uncertainty about possible page 2/ ... related health & safety factors.

3. Local Reports - continued

No representative from Local 2 was present, so there was not an official report read, but Jack Gegenberg mentioned that he was aware that another referendum to consider a union dues increase, was defeated (the third in the past year).

No representative from Local 4 was present, so there was not an official report from that Local. Sheila Perret, a member of Local 4 mentioned that the 2 reps from Local 4, Sheila Browne, and Rosemarie Reid, had recently been instructed by the Executive of that Local to not vote on issues at Provincial meetings until further direction from the Local 4 Executive. The membership has not considered this direction yet. Also, it was reported that the President of the Local, Janet Morris, tendered her resignation, effective Thursday, August 20, because she was considering an administrative position with the College.

Negotiations have been going on, and have recessed for 3 weeks following a solid 3 1/2 week, all day, every day, set of meetings.

It was asked of the meeting what the status of Local 4's per capita tax payments were, as at the non-quorate 'gathering' in July, and at the June meeting, it was reported that Local 4 continues to be consistently in arrears, in excess of the 90 day proviso stipulated in the Constitution. The Secretary-Treasurer reported that Local 4 was 90 days in arrears on July 28th, and that Local has not contacted the Provincial Office to report any hardship or difficulty connected with paying the per capita tax; (the Provincial wrote to the Local membership, in care of the Local Executive, in March, asking that they tell us if and when there is any difficulty with paying the amounts owing & there has not yet been a reply). Contact, by phone, with the Local Treasurer, has not resolved the problem of late payment. Members of the Provincial Executive were worried that the per capita, which has been collected from the membership and is really in trust for the Provincial, is not being forwarded & the idea of contacting the membership directly was rejected for the time being. It was agreed that some action must be taken on this issue. A total of approximately \$1600 is estimated in arrears.

The President directed that any further discussion on the matter of Local per capita tax was to be dealt with under item item 6(f) of the Secretary-Treasurer's report on Saturday morning.

Local 5 report: Dianne Kauffman submitted a written report, (see Appendix 'B'), and she and Lauma Avens, Provincial Co-ordinator, who is also a member of AUCE #5, added some news about grievances. Victory! A wrongful dismissal was settled with payment of back wages. The employee has been fired for not paying for items taken from the cafeteria after hours, she had made arrangements with another co-worker who agreed to leave the 35¢ on the cash desk, and forgot to do so. The employee was fired for theft. 3/...

the union grieved the dismissal, followed the grievance to Step 3 and then decided that the case should be dropped. In the meantime the Executive of the Local changed with annual elections, the new Executive was handed a Section 7 complaint (filed under the B.C. Labour Code) by the employee's lawyer on behalf of the member. The new Executive of AUCE 5 considered that the member had been wrongly dismissed and tried to re-open the grievance procedure. The College refused to hear the grievance and so the Local supported the member's Section 7 complaint in an effort to have the matter heard before the Labour Board and perhaps referred to arbitration. The Board hearing took nearly a week (back in March) and it has taken until this month for a resolution to the complaint. The Board found the case arbitrable. The union accepted responsibility for reimbursing the member's lost wages for the three week delay in properly representing the member at the grievance procedure and appealed to management to pay the lost wages since that 3 week mark, as a settlement. As of this week it has been announced that management has agreed that the dismissal was unjust and has agreed to pay the employee the approximately \$3000 in lost wages - the union will be paying nearly \$1000 - so the member will receive all back pay and the union was successful in having a just resolution to a wrongful dismissal. The member will not be returning to work at the College, having found a job elsewhere in the 6 month interim. The victory is that the union was successful in this case because they accepted responsibility for the Section 7 complaint - they agreed that they had not fairly represented the member AND because they supported the Section 7 they were able to argue successfully that there was a wrongful dismissal and that the college had a responsibility to re-open the case and either reimburse the employee's lost wages and/or re-instate her into the same job or one at the same rate of pay.

The other grievance news is that Local 5 is grieving a contracting out of bargaining unit work incident in that some employees in on area of the campus were laid off from their maintenance jobs and subsequent to that the college contracted out cleaning work in a newly built section of the campus - without hiring first the laid off employees with the experience and the seniority. The college has stated that all new services will be contracted out in the new wing. It would appear that the college is attempting to break the union financially by breaching the contract, refusing to settle at the grievance level and forcing the union to take clear issues to arbitration - a costly procedure.

- 6. Secretary-Treasurer's Report Sheila Perret, another holiday-maker of the Provincial Executive who had a glorious 2 weeks recharging ...

from the Canadian Farmworkers Union re seeking upport for their demands that the BC Labour Code be amended to provide minimum wage protection for farmworkers, and that the Workers' Compensation Act be amended to provide protection for farm workers who are injured on the job. The union asked that letters of support be sent to the Minister of Labour.

women charge the Department of Indian Affairs with mismanagement of Indian Affairs as well as poor housing conditions, high infant illness and mortality rates, loss of access to natural resources to maintain hunting, trapping and fishing rights, apprehension of native children and adoption of their children into non-native homes, 90% unemployment, high welfare rates, and lack of solid economic base free from government interference. The CAW ask for support for their 7-day occupation in the following ways:

a) that we support their demand for a meeting with John Munro

b) the resignation of Fred Walchli, head of the Vancouver office of the DIA

c) a full and independent public inquiry into the activities of the Department of Indian Affairs in the BC region

Mention was made of outstanding bills, most of which have accrued as a result of Convention, and the 2nd session of convention - approx. accounts payable = \$3800, part of which is \$1000 for the purchase of a new typewriter for the union office, an expense approved last Fall. The audit which was estimated by the accountant to be approx. \$1200 has been billed to us for \$1750, and this amount will be disputed with the firm by Sheila Perret, Sec-Treas. Two particular instances of misdirected billings from a courier firm, Loomis, on behalf of Local 5 were discussed and it was decided that the bills, since they are the result of Local 5 sending materials to Provincial, and sent without Provincial's knowledge, would be re-directed to Local 5 for their attention. The situation of Locals incurring expenses in AUCE Provincial's name was discussed briefly, and it was noted that Local 5 is not the only Local responsible for similar situations - a bill was recently redirected back to Local 1 for the same reason.

 - e) Secretary-Treasurer's Overtime authorisation for future O/T:

Sheila Perret reported that her overtime had been kept to a minimum of 6-10 hours per week since the Convention & that during some weeks, no overtime was necessary. The 6-10 hour figure was OK'd by the previous meeting, to be the limit. Peter Lane and Sheila Blace are working part-time in the office assisting with various duties, including the work running the referendum ballot. The hope was expressed that the referendum would approve the addition of a second paid officer, the Provincial Co-Ordinator on the Provincial Executive, and that would eliminate most or all of the overtime, and the need for part-time help.

f) Per Capita Tax status report: Sheila Perret

Local 1 is up-to-date and has been remiting on or before the 20th of each month - which is great.

Local 2 is behind and owes for July - approx. \$2650

Local 4 is nearly 4 months in arrears & owes for May June & July which is approx. \$1200+; the last time pct was received was on July 13 - the April remittance.

Local 5 is up-to-date

TOTAL ARREARS PORTION - approx. \$4000

After considerable discussion on the continuing lateness of Local 4's remittances, various suggestions were made as to a) get the Provincial dues b) inform the Local 4 Executive of their responsibilities and reminding them that we have been over this problem many times in the past year, and c) how to inform the Local 4 membership that the portion of dues that is being deducted from their pay is not being sent to the Provincial, and perhaps suggesting that we have some concern over the fact that monies basically collected in trust by the Local for the Provincial, are not being handed over. Also of the discussion centred around whether or not another letter should be written to the Local Executive before directing correspondence to individual members. We were concerned that suspension of membership in good standing would mean that Local 4 people would lose their voting rights which is a crucial issue to consider at this time, since Provincial Elections and the referendum on the second paid officer are underway it would also be unfair to suspend voting (8) ... rights when the ballots were sent out

Sheila Perret is preparing a 'synopsis' of the Convention for inclusion in the next issue. People were reminded to get written reports in for the paper.

- 8. Referendum Ballot Sheila Blace, Chairperson of the Trustees reported that the ballots went out on the 27th of July and that voting will continue until Friday, September 4th @ 4:30 pm. She thanked everyone who assisted with the printing, stuffing and sticking and reminded the meeting that the tabulation of the ballots will take place on Tuesday, September 8th in the Provincial Office. Results will be published on September 9th. The 2 week appeals period expires on September23rd. Supper will be provided for those who wish to eat on tabulation night. Notices of deadlines & dates to remember will be sent out to the 'hit list'.
- 9. New Executive for 1981-82 a) date of office

No formal decision was made to continue the part-time help in the office after August 31, 1981.

- d) Business related to status of co-ordinatorship no formal decisions on this item; Lauma Avens, who is running for the position was not at this portion of the meeting; two things were generally agreed upon:
 - i) that if the referendum does approve the addition of a second paid officer then the Provincial Executive will be reviewing the budget to allow for the increase salary expenditures.
 - ii) no other decisions should be made until Lauma arrives at the meeting, so the item was referred indefinitely and when it does come up for discussion we should consider what arrangements need to be made for Lauma's move to Vancouver from Prince George if she is elected.
- 10. Education Committee seminar plans

Sheila Perret, who is running for the position of Union Organiser, the Executive member responsible for chairing the Education Committee, mentioned suggestions for Shop Steward seminars, a campus work-shops on Sexual Harassment. More concrete proposals will be made at the next meeting. We haven't heard from Labour Canada about our grant application for \$2600 - if approved, the funding will finance the seminars.

- 11. Business Arising from Convention
 - a) Minutes should be ready for the next meeting
 - b) Up-dated Constitution Trustees responsibility

That the revised Constitution shall be printed and ready for distribution by the first week of November.

- People were reminded of on-going activities in aid of the Concerned Citizens for Choice on Abortion, the Democratic Revolutionary Front (FDR) in El Salvador and the Vancouver Branch of the Central America Support Committee. It was generally agreed that our prime concern should be servicing the locals, attending to local and cross-local matters as needed, and working on the affiliation lobby and that time and energy will determine the extent of our involvement with groups and organisations supported by AUCE.
- 12. Local Reps to the Provincial Executive
 - a) Responsibilities reports, etc. reps were reminded that they are responsible for submitting written reports to each meeting of the Provincial Executive, and the report should be suitable for publication in the Provincial Newsletter. Reports are to be typed and the facilities at the Provincial Office are available for this purpose.
 - b) Rights: to attend, voting privileges there was a general discussion on this point, with reps being reminded that all members of the Provincial Executive have voting responsibilities as representatives of their Local memberships. It was noted that the Local 4 Executive, a few months ago, directed that their 2 representatives not vote in any decisions of the Provincial Executive until further direction from the Local Executive. As noted in the Local 4 report, the Local 4 members have not considered this directive from the Executive. Provincial Representatives are also members of the Local Executives as a result of by-law amendments at all locals. The discussion on voting rights noted that if a Local representative is prevented from voting then they are prevented from participating and as they are responsible to their local memberships, it was questioned as to whether or not local executives could place restraints on members' rights in this fashion. There is nothing in the Constitution or the by-laws which allows the Local Executives to restrain their representatives on the Provincial Executive. The only way a Provincial Representative could be restricted from voting is through re-call procedures or through election of another rep at the end of a member's term of office.

 - c) status of current reps on the Provincial Executive

Local 1 reps - on until October 1981 currently have 2 representatives: Sheila Rowswell, Elizabeth Brock

Local 2 reps - on until October or November 1981 currently have 2 reps: Star Rosenthal, Roger Perkins

Local 4 reps - on until March or April 1982 currently have 1 rep: Rosemarie Reid; Alternate: Sheila Browne

Local 5 Reps - open nominations in September, elections in October currently have 2 reps: Dianne Kauffman, Tom Hedekar

Local 6 Reps - elections in February, take office in March 1982 currently have 1 rep: Jack Gegenberg; Alternate: Mary Mabin Jack will no longer be the Local 6 rep if he is elected Provincial Vice-President - so that office may be vacant on September 23/81

13. Old Business

a) status reports:

i) CUPW settled their contract nation-wide, only by a narrow margin of 52% in Vancouver; they achieved 92% paid maternity leave, modelled on the AUCE example at Local 1(UBC) & 2 (SFU)

That we send a letter of congratulations to the Canadian Union of Postal Workers and that we should mention in the letter our interest and willingness to meet with them to discuss union strategies on paid maternity leave.

ii) NABET/National Association of Broadcast and Entertainment Technicians - settled their negotiations with the CBC after a four month strike. Letter received from Loc.83 re support.

- iii) Canadian Farmworkers Union Jensen Farms and Country Farms still being picketed; picketing at the Naam restaurant on West 4th has stopped (Country Farms owns the Naam) and the matter of secondary picketing has been brought before the LRB by the Naam owners. See item 6.a) of these minutes for support on labour legislation demands by farmworkers.
 - iv) Democratic Revolutionary Front (FDR) the Convention donation of \$250 will be sent. Sheila Perret attended a rally at Robson Square in support of the FDR, August 15th, and expressed AUCE's support for the people of El Salvador.

- 13. Old Business continued
- a) v) PPWC/Pulp Paper & Woodworkers of Canada Wood industry strike is still on for PPWC; IWA and CPU have settled; PPWC is arguing that issues of local concern must be settled before the contract will be signed this affects the locals in the north of the province in particular.
 - vi) CALFAA (Wardair) still locked out; letter of support has gone to them as directed by unanimous consent by phone poll to do so last week.
 - vii) OTEU (ICBC) have settled to return to work, BUT have agreed to send the issues of wages and holidays to arbitration.
- viii) ATU/Amalgamated Transit Union Locked out on the first day of the Pacific National Exhibition; their mechanics walked off the job for one day during the week to protest the contract tentative settlement in that it does not provide parity with the wood industry workers.

Meeting ended at 1:30 p.m. Saturday. Next item of business was the Hearing re the Charges laid against Local 5 by Local 1 (under S.19 F. of the Constitution) re #5 CCU affiliation. See following pages for those minutes.

MINUTES

Of the Hearing held pursuant to Section 19 of the AUCE Provincial Constitution, Part F. The purpose of the Hearing was to hear the charges laid by AUCE Local 1 against AUCE Local 5.

The Hearing was conducted on Satruday, August 22, 1981, at Brittania Community Centre, in Vancouver, B.C.

The AUCE Provincial Executive conducted the Hearing, as per the Constitution. The charges were filed with the AUCE Provincial Office, by letter, as follows:

June 18, 1981

This is to inform you that the following motion was passed at AUCE Local 1's membership meeting today:

"AUCE Local One hereby charges AUCE Local Five under Section 19 (f) of the Provincial Constitution in that it affiliated to the Canadian Confederation of Unions in contravention of AUCE's policy decision to affiliate intact to the Canadian Labour Congress. Further, it is the position of AUCE Local 1 that a reprimand is totally inadequate given the severity of the situation, we urge that a hearing be held on the matter as soon as possible."

Signed, Wendy Lymer, Secretary-Treasurer, for Suzan Zagar, Vice President, AUCE Local One

Local I was represented by Nancy Wiggs, with the assistance of Don Chang, a UBC Law Student. Other Local I members present for the hearing included Suzan Zagar, and the Provincial Reps. Elizabeth Brock, and Sheila Rowswell. Irene McIntyre, another member of Local I also attended.

Local 5 was represented by Peter Burton, a UBC Law Student. Local 5 members present for the hearing included Lauma Avens, Local Trustee, and Provincial Co-ordinator; Judy Attewell, Local President; Kyra Guest; Isabel Bagg; and Dianne Kauffman, Provincial Representative. Local 5 was also attended by John Hartloff.

The proceedings were underway after Lid Strand, Provincial President, outlined the format for the day. Local 1 was to have gone first on outlining their charges, but Local 5 took issue with the Constitutionality of the charges, so Peter Burton, speaking for AUCE Local 5, argued that the Local 5 position that they considered the charges to be retroactive. This argument was based on Local 5's concern that since Section 19 (F)of the Constitution did not exist at the time the Local affiliated to the CCU, then the charges were being applied and heard after the alleged violation took place. Local 1 argued that the charges were Constitutional, stating that Section 19 of the Constitution, part (F), was the vehicle for the laying of the charges, and that Local 5 was being charged with violating other sections of the Constitution regarding abiding by AUCE policy. Local 1 emphasised that they were not charging Local 5 with violating Section 19 (F) but were using that section in order to deal with violations of other sections of the contract. Local 5 strongly objected to this interpretation of the Discipline section, and defended their action as being in line with Locals' rights to autonomous action.

of the charges, there was open discussion and a question period. Any formal decision making was the responsibility of the Provincial Executive, as per the Constitution. Decisions were made, motions were discussed and voted on, and a record of the motions considered is as outlined:

- 1. MOTION
 Jack Gegenberg (#6 Rep) Moved
 Elizabeth Brock (#1 Rep) Seconded
 That we rescind any previous motions regarding the constitutionality of the
 laying of the charges brought by Local 1 against Local 5 being in order.
 CARRIED
 - therefore it was understood that there are no motions on the floor dealing with the Constitutionality of the charges.

The Chair noted that there are now two points to be considered:

i) whether or not Local 5 is in violation of the Constitution, and

ii) whether it is appropriate to deal with this issue under Section 19 (F)

It was questioned whether or not there would be a conflict of interest if the Local reps that were participating voted on the issue, as this would include members from Local 1 and Local 5. The Chair ruled that all Local reps on the Provincial Executive were entitled to vote and to participate in the decision-making, and further, that under the Constitution, since the Provincial Executive has the responsibility of dealing with the matter, and since Section 7 of the Constitution defines the Provincial Executive as including the Provincial Reps then they shall have the right to participate.

 That Section 19 (F) may not be interpreted to apply to finite acts that occurred before the adoption of Section 19 (F) of the Constitution.

 That the Provincial Executive interprets Section 19 (F) as applicable to acts that are initiated prior to the implementation of Section 19 (F), and are still continuing.

 CARRIED
- 4. MOTION
 Sheila Rowswell (#1 Rep) Moved
 That the Provincial Executive finds that the charges laid by Local 1 against Local 5 regarding affiliation to the Confederation of Canadian Unions are constitutional.

 CARRIED
- Jack Gegenberg (#6 Rep) Moved

 That in view of the seriousness of the fine situation that we are dealing with, the entire matter shall be referred to a Special Convention to be heard within ninety (90) days and the entire Provincial Convention shall decide on the matter.

 DEFEATED
- 6. Local 5 members and other Local 5 representatives left the hearing after reporting that their membership had directed that they would not entertain participating in a hearing that decided the charges to be constitutional.

- 7. The hearing continued with Nancy Wiggs presenting the case for the actual charges, on behalf of Local 1. She cited Section 4 (e), 5(c), and 21 (d) as being those sections of the Constitution that her Local considered Local 5 had breached by their affiliation to the CCU.
- 8. There was no rebuttal from Local 5, as they had left.
- 9. The Chairperson asked for questions from the floor; there were brief remarks made about the charges.
- 10. MOTION

Mary Mabin (#6 Rep) Moved

Sheila Blace (Chairperson of the Provincial Trustees Seconded

That the AUCE Provincial Executive finds that in affiliating with the Confederation of Canadian Unions, Local 5 has violated the AUCE policy decision to affiliate to the Canadian Labour Congress by lobbying the Canadian Labour Congress.

CARRIED (Unanimously)

- 11. The proceedings continued with some suggestions and discussion on what the recommendations could be in view of the motion carried, and suggestions were as follows: (not necessarily in this order)
 - a) suspend the local indefinitely
 - b) suspend the local for 2 or 3 months
 - c) expell the local outright
 - d) reprimand the local without penalty
 - e) suspend for a certain length of time, i.e. 3 months, and if after 3 months Local 5 is still a CCU affiliate, then that local shall be expelled.
 - f) neither reprimand nor suspend nor expell the local, i.e. do nothing abour their affiliation
 - g) call a Special Convention to consider the entire matter
