Local Reports

Local #1 Report - Ian Mackenzie, Pat Gibson, & Heather McNeal A few momentous things happened - 7 day strike, picketting 24 hours a day with the upshot that they succeeded in retaining most of the things won in the 1st contract. The main thing they won was wage restructuring so that they have equal pay for work within the bargaining unit but not campus wide. There were a couple of arbitrations. Ian and another member were suspended for 5 days for refusing to do work not in their job description. The arbitrator, Richard Bird ruled to reduce suspension to 1 day and defined job description and job specification. Emerald Murphy won her job classification arbitration case with arbitrator Al Spragg. They are starting an arbitration case dealing with lay-off. When the Hospital Employees Union at VGH went on strike Local 1 had 85 members who were faced with a picket line. Pat Gibson went on to say that 80 AUCE members crossed the picket line and the problem is that some people believe they are essential services and no matter what other people said they were going to go to work. At a membership meeting it was moved and carried that no AUCE member was to cross the picket line, but VGH members did not agree and continued to cross. The issue has not been resolved. Ian continued stating that at the last membership meeting it was decided to have a standing strike committee. They decided to have a steward seminar at work but the University refused to allow all the stewards off work at once and they are considering doing a grievance against the University on this issue. They have adopted a new discipline procedure but it hasn't been used yet. Heather McNeal referring to the HEU strike stated that hopefully Local 1 has learned to be more prepared. Pat Gibson discussed an arbitration case that the union lost dealing with the firing of an employee during the probation period. Ian Mackenzie concluded the report with the arbitration case about Secretary 2B's that were finally sorted out by a joint committee, so that some were reclassified to Sec. 3 and some were moved back to Sec. 2.

Local #2 - Perce Groves
Since the November convention AUCE Local 2 has weathered a short strike, a L.R.B. decision on inclusions in the bargaining unit under Section 34, an appeal of that decision by the University, layoffs, four arbitrations and an arbitration appeal.

On June 3 the campus workers certified under a polyparty agreement, mostly tradesmen, set up picket lines for a little over 24 hours. They are using the strategy of short strike action at key times which has been used effectively by Locals 1 and 2 of AUCE. Probably due to a hard-line approach taken by a membership meeting earlier in the week, no AUCE members crossed the line to work, although some did cross to attend classes without permission. There was strong feeling that the strictest disciplinary action possible

should be taken against scabs, and that power to discipline should rest solely in the local association.

The section 34's were finally ruled on, the University appealed this decision with the final result that about one-half of the employees for whom we originally applied are in our unit. Except for personnel office employees, all those whom the University was claiming on grounds of confidentiality are in the unit, and all the non-management computing centre employees below Grade 13 are included. Hearings on the inclusion of

student assistants begin on June 23.

There was a successful arbitration concerning starting times of some employees in the Library. We took to arbitration without success the question of whether Union representatives should be paid by the University for time spent at arbitrations. Although we were successful in obtaining retroactivity for 4 full-time continuing employees who applied for reclassification prior to the signing of the contract (netting them \$1300 each), we were not successful in an arbitration concerning a student assistant who was reclassified after certification into a continuing full-time position.

A very few matters were solved at the Grievance Committee level: employees of long standing were allowed to join the dental plan; a temporary foyer was added to the library for the winter so that employees in the loans division could work without fur coats. Much time has been spent in trying to convince management that the Grievance Committee cannot/will not renegotiate the contract.

Perhaps the greatest strength we have as we begin preparations for our second contract negotiations is the solidarity shown during the strike of the other workers on campus; certainly our greatest weakness is illustrated by the fact that only after three months had expired after the end of our last president's term were persons nominated who were willing to stand for election to that office.

Local # 3 Report - Steve Geller

We have spent the last year watching the demise of our institution and it's just a stone's throw away from completion. The unions main activity has been self-preservation. There are no lay-offs without union sanction, which is quite unsatisfactory in practice because you participate in the elimination of your own job. It also means that we agreed tacitly that budgetary cut backs would occur and each dept. had input into how it would happen. Some high seniority people agreed to take a portion of the low seniority people's lay-off. The problem is that the administration is so disorganized that there have been 8 proposals in 6 months regarding the budget cuts and with each proposal the union has to respond.

Two arbitration cases about vacation pay were both won. A referendum on bumping was conducted because it was not in the contract. The membership voted to bump only within departments which means that virtually there is no bumping (because depts. are so small). Referendums should be carefully phrased. We discovered in the local press that the Minister of Education through the voice of the major of Nelson has issued a threat that the contract negotiations must be carried out in a judicious fashion or the budget will be withdrawn. Faculty and staff see this as unfair bargaining and will probably institute formal proceedings with the Labour Board and will probably call for help from the Provincial. NDU may wind up having Selkirk College take over. The Social Credit government do not care about the area because it is a dead riding (strongly NDP). They also don't seem to care about the issue of education in the interior. Contract negotiations start Tuesday with the Board of Governors but maybe we will really be talking to Victoria. Apparently the merger with Selkirk College has already begun so maybe we will be actually talking to Selkirk administrators. NDU is still a private institution and terms to become public have never been spelled out. Staff are really demoralized and it is hard to get them to do any planning for the future.

Local #4 - Karen Kjarsgaard
Elections have been held and almost all the positions have been filled. It seems that
people are getting involved and getting active. The faculty called a strike vote in
April and gave notice. The union didn't know what they would do but the membership
passed a motion of support. The faculty negotiations were tabled and are to resume in
August. So that faculty and staff may end up striking together. There has only been I
grievance and it was a class action dealing with job reclassification. The grievance
procedure time limits have been extended. The college tried to lay 2 members off due
to technological change. They had forgotten all about the clause in the contract. It
now seems that it may be 3 months before they can lay these people off.

Local #5 - Prince George
On May 31st we invited Melody Rudd to attend our staff association membership meeting and voted to affiliate to AUCE. There are presently 44 people signed up out of a possible 68. They would have more but lots of people are on vacation.

In negotiations they we offered 2%, faculty was offered nothing and administration were offered a cut back of 10%.

The faculty is certified.

They hope to certify to the Labour Board very soon.
