Administrative history / Biographical sketch

Note

Duncan Stacey was born December 26, 1945. He earned a B.A. in economic history in 1970 and an M.A. in history in 1978, both from UBC. He held many positions in the fishing industry over his lifetime including commercial fisherman, tenderman, seaman, and cannery fish inspector, in addition to working as a researcher and consultant in the fishing industry. He was a consultant and expert witness for the Department of Fisheries and Oceans, as well as other industry organisations, regarding legal cases related primarily to First Nations fishing rights. He wrote many published works on the subject of fisheries in BC, including two co-authored books: *Corklines and Canning Lines* (1992) and *Salmonopolis: The Steveston Story* (1994). He also conducted curatorial and consulting work for the Canadian Museum of Civilization, the Canadian Postal Museum, and Parks Canada, including the Gulf of Georgia National Historic Site, before his death in 2012.

Scope and content

Fonds consists of documents related to Stacey's career as a fisherman, historian, writer, researcher, curator, and consultant. Materials include correspondence, photographs, recorded interviews, reports, handwritten notes, clippings, research materials, prints, postcards, ephemera and other documents. The "Gulf of Georgia files" series was arranged by the records creator and has been respected. All other series have been imposed by the archivist and arranged according to materials that relate to Stacey's roles as expert witness in various trials, historical and industrial researcher, collector and curator, and commercial fisherman, respectively. Where correspondence and photographs were stored separately by

the records creator, they have been retained together in series according to their document type; otherwise, file integrity has been respected and these materials may be found in other series as well.

A significant amount of material, consisting primarily of copies of photographs obtained by Stacey from various archival institutions, has been removed.

Series consists primarily of photocopied materials, as well as correspondence, handwritten notes, published materials, and other documents related to Stacey's research and curatorial work for various displays and exhibits, primarily for the Canadian Museum of Civilization. Stacey's own collection of industrial and outdoor clothing is also documented, as it overlapped with his research interests and curation on behalf of museums. Unless otherwise noted, file names and order within files have been respected.

Scope and content:

Series consists of Stacey's research files related to the fishing industry. Unless otherwise noted, files consist entirely or predominantly of photocopied materials that have, to varying degrees, been organised, highlighted, and annotated by Stacey. Files also contain some handwritten notes, published materials, interview transcripts, and correspondence, all of which relate primarily to First Nations

fisheries and licensing. Other topics include: fishing techniques and equipment; fish species; fisheries unions and workers; the Department of Fisheries and Oceans and fisheries legislation; the Hudson's Bay Company; various canneries in BC; Steveston, BC and its Japanese community, and more. These files were used by Stacey in his various roles as historian, researcher, author, expert witness, and consultant.

Whenever possible, file names and order within files as given by the records creator have been respected.

Physical description: 2.94 m textual records and other material.

Canadian Fishing Company

Date: [1928 - 1981] (date of creation)
