## Administrative history / Biographical sketch

---

### Note

Jackie Maniago was born on October 3, 1936 in Trail, British Columbia. She began her involvement in advocacy for persons with intellectual disabilities after the birth of her youngest son, Norman Maniago. While she desired to take care of Norman at home, her husband (Walter Maniago) and her were unable to do so. Norman was placed into care at Woodlands, an institution serving people with intellectual disabilities. Jackie Maniago found there was little support for her family and families of other Woodlands residents. She and a group of other parents of Woodlands residents came together to create the Woodlands Parents' Group (1976), which later helped form the Community Living Society (1978), Family Link Society (1983), and the Community Brokerage Service Society (1988). It was these efforts to improve the quality of life for people with intellectual disabilities that led to the closure of Woodlands, investigations into the abuses inflicted on Woodlands residents, and the beginnings of the Community Living movement in British Columbia and the rest of Canada.

### Custodial history

The fonds was donated by Jackie Maniago to the Community Living Society. The Community Living Society then donated the records to Rare Books and Special Collections at the University of British Columbia in January 2014.

## Scope and content

---

The fonds consists of records created and collected by Jackie Maniago which includes records associated with her involvement in various advocacy efforts in Vancouver, British Columbia, and Canada. In particular, the fonds includes records related to the Community Living movement, deinstitutionalization in British Columbia, and advocating for the rights of persons who are intellectually disabled.

The fonds has been arranged into the following 10 series: Woodlands Parents' Group; Community Living Society; Community Brokerage Service Society; Family Link; British Columbia Association for Community Living; Canadian Association for Community Living; Community Living Coalition; Subject Files; Advocacy Initiatives; and The Roeher Institute. These series reflect Jackie Maniago's activities and participation in these organizations and her own interests.

The main types of records within the fonds include correspondence, meeting minutes, news articles, photographs, interviews, event programs, publications, newsletters, conference proceedings, and speeches.

## Series descriptions

### Woodlands Parents' Group

Date: 1973 - 2009 (date of creation)

Scope and content:

The Woodlands Parents' Group was an independent group of parents whose children were residents in Woodlands. They organized themselves as a support and advocacy group for deinstitutionalization and community living. Through their efforts, they successfully lobbied the Government of British Columbia to close Woodlands and support community living for residents of Woodlands.

Series consists of records created and collected by the Woodlands Parents' Group, of which Jackie Maniago was a member. Records include meeting minutes, reports and briefs written by the Woodlands Parents' Group, general correspondence, news articles and other records related to Woodlands and the services provided there, and records related to the lawsuit brought forth by survivors of Woodlands.

## Community Living Society

Date: 1976 - 2010 (date of creation)

### Scope and content:

The Community Living Society (CLS) was created by parents from the Woodlands Parents' Group in 1978. The purpose of the society was to provide support and services for Woodlands residents who were transitioning to community living, but has expanded its services to serve all those with developmental disabilities and acquired brain injuries. They provide personalized, flexible home and community opportunities, respecting the uniqueness of the person with a disability, families and networks.

Series includes records from the Community Living Society and its predecessor, the Community Living Board. Records include meeting minutes and agendas; reports, proposals, and projects authored and led by the Community Living Society; newsletters; correspondence; interviews; speeches; and the documentary, Breaking Through.
