OTEU Report, by Carol McQuarrie and Anne Gilbert

Met with Opal Schilling, Sec.—Treas of Local 15, and Bill Evers, OTEU organizer
60,000 members in Canada, 200,000 members in the USA. International union with
a yearly international convention. Last year was the first Canadian convention.

In Quebec and in Eastern Canada OTEU has small locals, in the workplace, but in
B.C. they have two large locals - Local fifteen, with 164 bargaining units, and
Local 378, which originally a company union for BC Electric - with BC Hydro became
certified with OTEU. Bargaining units all over B.C. and in the Yukon. Freightways
Co., Transportation companies, also in Albærta. Membership in B.C. is 2050.

White Collar Union. No jurisdictional problems. Directly affiliated with CIC,
Local 15 collects dues and pays per capita. Five general membership meetings per
year. All staff hired by Executive Board. Most of Local 15's members are
staff people in trade untion offices. CU&C, Credit Union branches, Burrard Yarrows.

OTEU recomends that if AUCE were to become affiliated with them it would be more beneficial to join as one local rather than as five locals; AUCE members would sign Local 15 cards and become members of Local 15 until the international convention in June, at which time it would be recomended by Local 15, 378 and the Canadian Council that AUCE be given it's own charter and their won local. The explanation was that AUCE could remain intact and retain its character as a posteducation support staff.

Three business agents to service 164 locals, provide steward straining - developing
manual.

Percentage female to male - eighty percent women. Average base rate is 1000.00 mon. Stress negotiating shorter hours. Wage indemnity plan.

The relationship of the wage indemnity plan to maternity leave was discussed; to be clarified by Ann and Carol.

Negotiate top wages for temps - instead of other benefits. Ranges from 8.060 to 9.95 for part-time casual temporary. Asked about across the board vs % raises, sd they don't like large gaps, wil 1 sometimes go for across the board \$ increase to narrow. International strike fund, \$20.00 wk; Local 15 pays lost benefits but does not have a strike fund. \$10.000 defense fund. Stewards and negotiating temas elected by union. Business agents are also elected.

Re: strike policy - if there is a strike pending, they go to the Fed which calls in affiliates - sometimes a strike can be averted. Prepared to offer AUCE a local of their own. Dues structure similar to AUCE's. Union Education - Vancouver and District Labour Council offers spring and summer courses at SFU; they send

and District Labour Council offers spring and summer courses at SFU; they send stewards. Sixty people at UBC; the largest local is CU&C with 100.00; Burrard shipyards second with 85. ICBC is local 378.. Fred Trotter and Bill Evers would be very glad to meet with us. (International President)
