## AUSTRALIAN TRADE AGREEMENT, 1931.

You are advised that by Order in Council (P.C. 2412), dated the 29th September, 1937, it is ordered that, on and after the 1st October, 1937, and for so long as the Trade Agreement between Canada and Australia remains in force, goods the growth, produce or manufacture of Australia, shall, when imported direct into Canada, enjoy the Tariff treatment hereunder indicated:-
