2. Local Affiliation meetings, on campus: Locals 2&6 - Jan. 17th

3. Delegate Elections for representation at the Special Convention:

Motion: That Affiliation Committee reps to back to the locals, put notices up advertising the meeting, and get the stewards to solicit information. Moved: Suzanne Marria 2nd: Sheila Perret Carried

There was further discussion about the feasability of organising meetings between the affiliation Committee and various groups within the unions being investigated; it was agreed that a good idea would be to set up sub-committees withing the Affiliation Committee to meet with:

 BCGEU - rank and file caucus and especially Bob Peacock, member of the BC Ferry and Marine Workers' Union.

2. Women's Committees - in the various unions, and in the CLC & BC Fed 3. Rank and File Formations.

It was agreed that the whole Affiliation Committee would not meet with the Rank and File formations because of time restraints, rather that some interested members of the Affiliation Committee would meet as their personal schedules allowed, bring reports back to the Affiliation Committee, and consider inviting representatives of those unions to speak at the local affiliation membership meetings.
