## 1. CALL TO ORDER

A. Kiernan, the Chair, called the meeting to order at 12.35 p.m.

#### 4. CONTINUING NOMINATIONS FOR OFFICERS

2nd Vice-President

The chair asked for any nominations for 2nd Vice-President, (responsible for chairing the Contract Committee) There were no nominations so nominations remain open.

Trustee

The Chair asked for nominations for Trustee. No nominations put forth. Nominations stay open.

Sargeant-at-Arms - 2 positions

No nominations for Sargeant-at-Arms - nominations remain open.

#### 5. COMMITTEE REPORTS

The President's Report

At this time the President spoke on the two motions presented.

- (a) "that approval be granted to send 5 delegates to the CUPE National Convention in October, 1987, being held in Quebec City". This motion was moved and seconded by the Executive, setting policy for sending delegates to National Convention on behalf of the Union. We would like a vote on sending the following to the Convention. The President, First and Second Vice-Presidents, Secretary-Treasurer and the Chief Steward. For those officers who cannot attend, there would be alternates from the Executive or chairs of the standing committees who could replace them. The motion was called and CARRIED
- (b) "that the membership approve the Hiring Committee's selection of Business Agent".

The chair informed the membership that we had received 67 applications to our ad for a Business Agent, which we short listed to five people, four female and one male. Our first choice was for Barbara Carmichael. We were quite enthused about our first choice, so it was with disappointment we learned that Barbara was unable to accept due to serious illness in her family in Ontario. We are well pleased with our second choice, Rod Haines, who is no stranger to the Campus. Adrien outlined his background and experience. He is very well educated, and his greatest asset is his organizing ability..

This motion to accept the selection of the Hiring Agent was approved by the membership. Carried

Joe Denofreo spoke to the members on position of Bill 19.

He discussed B.C. Federation of Labour's non-compliance program in Boycott of Bill 19 legislation. Cupe is an affiliate and supports the Federation's boycott. We will not be appearing before the new Labour Relations Council on any Labour Relations matter unless the Council subpoenaed us and at that point we will argue that in the Courts and if we lose the argument in Court then we will make the decision either to go to jail or appear before the Council. As an example he stated that rather than accepting Government mediators, mediators that would be acceptable both to the Union and the employer would be found outside of the Peck Commission.

We are endeavouring to work these things out with the Employer.

Adrien now introduced Rod Haines to the members, and they gave him a warm welcome. Rod spoke briefly and said he is happy to be with us.

## Treasurer's Report

The Treasurer is absent today. There will be financial statements going out with the Newsletter. There is a motion from the Treasurer which was seconded by the Executive Moved Ellis/Executive:

a) "that the printing budget and the newsletter budget be combined and that the total amount for this budget be increased to \$8,000.00".

Moved Lundrigan/Hutchinson an amendment to above motion that the portion allocated to the Newsletter be 40% and the Executive Minutes be 60% of the total budget. Carried The question was called on the amended motion. Carried

#### Contract Committee

There is a report on this Committee in the Newsletter. We now have contract language proposals from the University. Our next meetings are to be held August, 12, 19 and 21 and September 11, 1987.

We have received resignations from Lois Bishop and Trevor Tunnacliffe. The President made a plea for members to get involved in this contract committee, for negotiating etc.

## Grievance Committee

One anticipated arbitration settled. Two policy grievances settled and five personnel grievances settled..

Some of the problems are to do with hiring. Other problems are involuntary transfers. We have members asserting their rights under 22.08 and then not feeling confident in their new position became of the employer giving them a bad time. There are many reclassification issues, such as appeals denied, and date of retro pay. The important thing is we are dealing with these problems and settling them and the University is changing and trying to resolve the differences between us.

Communications Committee

We welcome social get togethers where we could have differenct types of speakers, films. It does not necessarily have to be Union issues. We plan some small refreshments.

#### OTHER BUSINESS

Suzan Zagar spoke on the recent step increment, pointing out that this increment was diminished due to increase in Federal Income Tax occuring. The President added that the Finance Department will look after any omission of increment due to their part, i.e. errors. Please call them if you have any questions.

The President strongly urged members to get in their answer to the questionnaire on use of VDT's.

Once more the President seeks diversity in the Contract Committee members and for the other Committees also. It is not all research. We are entitled to take five people with us to the bargaining table. Members are entitled to take leave from work while helping on these committees. Next session for the contract committee will be August 12. Usually meetings are twice a month and on a Monday night.

Suzan Zagar asked for volunteers to sit for the Job Evaluation Committee in our bargaining unit for the next round of negotiations. It is extremely important to get members for this project, that is if we wish to improve our standards and make a good case for a substantial wage equity settlement..

The President decided to bring this meeting to a close. She urged people to get interested in selecting various films, or any ideas that they may have to make our meetings more interesting and educational. She will advise the University that this has only been a one hour meeting and that people will be returning to work.

The meeting was adjourned at 1:30 p.m.

- 5. Any material submitted after 4:00 p.m. on the deadline date (fourth Thursday of every month) will not be considered for the current newsletter.
- 6. In the event of too much material, the newsletter will consist primarily of union news, as prioritized below.
- 7. It is the responsibility of each Committee/member to submit material for the newsletter. All materials must be original typed and of camera-ready copy.
