ii. **B.C. Federation of Labour Affiliation**

Paul referred to the diagram in his report in p.4 of September's newsletter. All locals of CUPE are automatically affiliated to the Canadian Labour Council (CLC) and CUPE National. 270,000 members affiliated to the B.C. Federation of Labour. Ken Georgetti and Angela Schira are two officers of the B.C. Federation of Labour. Vancouver & District Labour Council regroups members of the CLC and the B.C. Federation of Labour at the local level as does the Metro Council for CUPE Labour at the local level as does the Metro Council for CUPE -B.C. Division.

In general we work for a public and political body at UBC. In order to get assistance from the B.C. Federation of Labour we would have to go "cap in hand" because we aren't affiliated.

If we took job action then the B.C. Federation of Labour would assist with strike coordination in that it would encourage Union affiliates not to cross our picket lines.

The dues are \$0.60 per member per month or approximately \$900.00 per month.
