- 2.) Section F.6., Election of Officers: to read "The Contract Committee and Communications Committee shall elect from amoung their members a Chairperson to serve on the Local Association Executive. The stewards shall meet annually in October to elect form amoung themselves a Chief Steward who will serve as Chairperson of the Grievance Committee."

Sandy Lundy read a letter to the Canadian Union of Public Employees. It was moved by Ray Galbraith and seconded by Jennifer Clemmons to "send the letter to C.U.P.E. as drafted by Sandy with the addition of a reference to the two submissions which are before the board in which C.U.P.E. is mentioned." The motion carried.

Sandy Lundy moved and Jackie Ainsworth seconded "that a meeting be held to discuss the Universities Act as it relates to staff." The motion carried.

Sandy Lundy gave the financial report and moved its adoption seconded by Judy Katz. The motion carried.

Sandy Lundy moved and Jackie Ainsworth seconded "to put an item in the newsletter calling for financial pledges." The motion carried.

A report on preparations for negotiations was given by Jennifer Clemmons. Jennifer Clemmons moved and Lorraine Langille seconded that, " division meetings be called for: a.) discussion of demands for negotiations. b.) election of division representatives to the contract committee. c.) election of mivision stewards. The motion carried.

Jennifer Clemmons discussed the formation of a research committee and asked for volunteers to do research.

Jackie Ainsworth gave a report on VGH and moved, seconded by Mrs. Evelyn Cox to "send a letter to the VGH people explaining the bargaining unit." The motion carried.

Jean Rands announced a meeting friday night to meet with people from SFU.

Jean Rands gave a report on the office and it was moved by Jennifer Clemmons and seconded by Sandy Lundy to " keep the office for one more month" and amended " and to do a utility survey." Both the amendment and the motion passed.

The meeting was adjourned at 6:55.

DRAFT LETTER TO CUPE

Mr. Ole Johnson, CUPE.

Dear Ole,

1. The membership of AUCE look upon CUPE members who work at UBC as colleagues and fellow trade unionists. Our union has received many expressions of good will and encouragement from our fellow workers; however AUCE has never characterized these as other than personal good wishes or moral support. We have never said we have the legal or financial backing of CUPE.

Indeed throughout our membership drive we have had offers of financial help from other Canadian unions but have preferred to rely on our own resources and retain complete autonomy over our affairs.

2. The group of UBC employees we have been organizing - non-unionezed,

non-professional and clerical workers - comprise a large number. We are aware that staff turnover is high and that orgaization is not easy. Nevertheless the organizing committee of AUCE undertook this difficult task when no other union was prepared to do so. We have consistently said we wish to form an independent Canadian union which would serve the particular needs of our membership, and consider that proposing affiliation with an established trade union now would be a betrayal of trust.

3. The executive of AUCE look forward to co-operating with CUPE in the future, and wish you all the best for 1974.
