 The motion was seconded by Ian McKinzie, and the motion carried.

Jean Rands moved and Heather McNiel seconded that: "A.U.C.E.'s first contract with UBC should include provisions for a general two-hour lunch break on a specified day each month (i.e., the second Thursday of each month) to enable everyone to attend the union meeting." The motion carried.

The meeting was adjourned at 7 o'clock.
