

Dear Sir.

Importation into Germany of Butter, Cheese, Coffee, etc.is, as you will know, subject to strict regulations. A certain shortage prevails, and in turn the said goods are on a high level. In order to relieve the situation for families or persons who are not well off the German Government has granted exemptions from the import regulations, to the effect that people living outside Germany can send "Liebesgaben" to relatives or friends in Germany.

We are packers and exporters of Danish Provisions, and from different business friends domiciled outside Europe have been requested to send such "Liebesgaben" to German citizens. We believe that many residents in/U.S.A. when informed of the situation would welcome an opportunity of being of some help to friends or relatives in Germany, and therefore we have now organized the forwarding of such "Liebesgaben" on a wider scale.

The exemption granted on the part of the German Government permits "Liebesgaben" of maximum 5 kilos and consisting of Butter, Cheese, Coffee, Tea, etc. Packages which we have sent forward so far have comprised the following quantities:

We have also arranged for "Liebesgaben" comprising Butter only, the cost of which is as follows:

 $2\frac{1}{4}$  lbs. (1 kilo) of Choicest Danish Butter - \$ 1.50.  $4\frac{1}{6}$  - (2 -) - - - - \$ 2.25. Also for the above is packing, postage, etc. included, (Postage alone is close to half a Dollar).

Unfortunately we have not the pleasure of knowing the name of your Association or of your goodself, but have not hesitated in bringing to your knowledge the fact of the above exemption from present regulations, as we feel convinced that with information in hand on the subject, you may desire to bring the news before your members. We have applied at Berlin for the names of the leading German papers published in the States, but have not yet received such information, which prompts us to communicate with you.

If the matter finds response among your members we request from you a list with names and full addresses of the friends or relatives in Germany to whom the "Liebesgaben" should go forward. Please state on the list whether the "Liebesgaben" should comprise the 5 kilo package as specified above, or should comprise Butter only, and please include along with your instructions a banker's cheque in settlement of the total amount, at the rate of respectively \$ 3,00, \$ 1,50, or \$ 2,25, as mentioned above.

In the event that fresh regulations might come into operation preventing us from sending forward precisely the goods specified above, we will regulate the "Liebesgaben" accordingly. If fresh regulations in Germany might prevent the dispatch, repayment without any deduction will of course promptly be made to you.

Our company may probably not be known to you. We therefore take this opportunity of enclosing an illustrated pamphlet showing the goods on which we concentrate as packers and exporters, which pamphlet at the same time gives a short review of our firm. For reference we beg to refer to: Privatbanken i Kjøbenhavn, A/S, Copenhagen, and likewise our firm is well known to the Royal Danish Consulate General at New York City.

We request the favour of your attention in bringing this matter before your members and solicit your news in the course of post, if we can be of service to you.
