

RECOGNISANCE OF BAIL.

COLONY OF VANCOUVER ISLAND }
And its Dependencies,
To Wit:

BE IT REMEMBERED, that on the *thirty first* day of *July*
in the *thirtieth* year of the reign of Queen Victoria, *Philip*
Hankin and *Thomas Wilson*

cometh before me, *Augustus Pemberton Esq*, one of Her Majesty's
Justices of the Peace for the said Colony, and severally acknowledged themselves to owe to our said
Lady the Queen, that is to say the said *Philip Hankin and*
Thomas Wilson in the sum of
Five hundred dollars each,

to be respectively levied of their lands and tenements, goods and chattels, if the said *Philip*
Hankin and Thomas Wilson
shall make default in the performance of the condition underwritten hereon.

The condition of this Recognisance is such that if the above bounden *Philip Hankin*
and Thomas Wilson
shall personally appear before the Justices of our Sovereign Lady the Queen, (assigned to keep the
peace within the said ~~District~~ *Colony*, and likewise to hear and determine divers felonies, trespasses, and other
misdemeanors in the said District committed,) at the next *Assizes* ~~Sessions~~ *of the*
Peace to be holden in and for the said ~~District~~ *Colony*, then and there to ~~answer~~ *prosecute and give evidence*
Queen, for and concerning the *Charge of Perjury*
with suspicion ~~whereof the said~~ *Timothy*
stands charged before *Augustus Pemberton Esq* the said
Justice, and to do and receive what shall by the Court be then and there enjoined him, and shall not
depart the Court without license; then the above written Recognisance shall be void.

is charged this day before me
for that he the said Timothy
on the twentieth day of July
in the Year aforesaid at Victoria
in the Colony aforesaid in his
examination as a witness at a
certain Coroner's Inquest held
on the body of Edmund Wain before
Augustus Frederick Pemberton,
Gentleman, Coroner for Victoria,
Esquimaux, and the districts lying
adjacent thereto in the Colony aforesaid,
falsely, wickedly, wilfully, and
corruptly did commit wilful and
corrupt perjury. Against the
Peace of our Lady the Queen her
Crown and dignity.

the Peace for the said Colony of Vancouver Island and its Dependencies, who being sworn upon his Oath,

saith

on the twelfth day of July instant an Indian named Timothy who was examined as a witness at an Inquest held at the Police Court Victoria in the Colony aforesaid before Augustus Frederick Pemberton Gentleman Coroner for Victoria, Esquire and the District Magistrate thereto stated, as follows: "On Sunday night last I was at my sisters house. I slept at my sisters house on Sunday there is one bed in the house to which I had my supper at six o'clock and did not go out afterwards. I then went to sleep. He afterwards on being confronted with another witness stated that the foregoing statement was untrue saying "It is all a lie because Tom was the cause of my being arrested" previous

to making this false
he the said Timothy was
sworn on oath, "to tell the
truth the whole truth, and
nothing but the truth."

I charge the said Timothy
with committing wilful
and corrupt perjury in
his examination as a
witness as aforesaid on
the day and date aforesaid
and at the place aforesaid.

Philip Naukie being duly sworn
on oath deponeth and saith,

I have heard my information
read it is true.

The prisoner was
examined as a witness
at the Inquest which
was held to inquire
into the cause of the
death of Edmund Wrin;
~~and~~ the prisoner was
required to account for
his time on the night
on which the said
Edmund Wrin was
supposed to have been
murdered; the prisoner
was in company with
an Indian named Jim
who had in his possession
the clothes and lining
of the murdered man
Wrin; on being examined
the prisoner Jimmatt, said
he was at his sisters
house on the night of the
murder, he shortly afterwards
denied this statement
and said he told a lie
because Tom another Indian

was the cause of his
being arrested.

The prisoner was examined
as to whether he knew
the nature of an oath,
and I am satisfied from
his manner at the time
that he perfectly
understood the nature
of an oath, whilst
being sworn he made
the sign of the cross
and in reply to a question
by the Coroner as to where
he would go hereafter,

if he told a lie, he said ~~to~~ "Que Cooly"

The prisoner's sister
he referred to is living
with a man named
Wilson.

There were other Indians
examined at the Inquest
as witnesses, and they
were all unwilling to
give their evidence truthfully,
which has the effect
of defeating the ends of
justice.
