Introduction

In an endeavor to ensure that the Canadian Association of Industrial Mechanical and Allied Workers' (CAIMAW) role and contribution to British Columbia's historical development is preserved, the CAIMAW has agreed to donate its records to the University of British Columbia Special Collection Division.

After a preliminary appraisal, the transfer of records was completed in May 1992. There is expected to be further accruals to the fonds and there are to be no restrictions on the material to the public for research purposes.

Administrative History

The Canadian Association of Industrial Mechanical and Allied Workers (CAIMAW) was initially formed in Winnipeg, Manitoba in 1964, as a result of local workers dissatisfaction with the International Moulders' Union. Also in the mid-1960's, in the aftermath of the "Lenkurt Dispute" in Vancouver, B.C., the Canadian Electrical Workers Union (CEWU) was in the process of being formed. The formation of the CEWU was also, in part, the result of worker dissatisfaction with the international union structure, in the CEWU's case, the International Brotherhood of Electrical Workers.

CAIMAW and the CEWU officially merged in December 1969, around the same time as the formation of the Council of Canadian Unions (CCU) - later renamed the Confederation of Canadian Unions in 1973. After 1971, CAIMAW underwent a series of ideological and organizational changes which have remained essential to the union's philosophy up to the present. The re-organization of CAIMAW, after a Special Convention held in 1971, witnessed the re-establishment and constitutional entrenchment of the basic principles upon which the breakaway union was originally conceived. More specifically, these included the notions of a purely Canadian based trade union movement as well as democratic control of the union by the membership. Needless to say, after 1971, the ideological shift from business unionism back to rank and file control initiated a significant re-arrangement of CAIMAW's constitutional and organization structure.

Throughout this period, CAIMAW has also maintained a close relationship with, and membership in, the CCU. In

fact, CAIMAW's National Secretary-Treasurer, F.H. 'Jess' Succamore, has also played an important role in the CCU's development, initially as a delegate at the CCU's founding convention in Sudbury, Ontario in 1969, and later as both vice-president and president .

On December 18, 1991 the 6,500 members of CAIMAW voted to join the Canadian Auto Workers (CAW). CAIMAW membership voted 82 per cent in favor of the merger. As a result, after 27 years CAIMAW has again evolved in an effort to foster and support both a democratic and principally Canadian based trade union movement.

Scope and Content Note

The fonds of the Canadian Association of Industrial Mechanical and Allied Workers (CAIMAW) covers the years 1964-1991, and is contained in 57 boxes. CAIMAW was initially formed in Winnipeg in 1964, merged with the Canadian Electrical Workers Union (CEWU) in 1969 and after 1971, reorganized structurally and relocated in Vancouver, B.C.

Most of the record series derive from the National Secretary-Treasurer's office, while the remainder of the records have been generated by various staff representatives. CAIMAW's National Secretary-Treasurer was constitutionally responsible for maintaining/housing the union's records, therefore, all the major record series, for example, the National Executive Board Correspondence and Meetings and the Conventions proceedings etc., are of his provenance. The remainder of the records pertain to the servicing and organizing functions of the union which was primarily the responsibility of the various staff representatives.

From 1971 on, CAIMAW was officially affiliated with the Council of Canadian Unions - later renamed the Confederation of Canadian Unions (1973). In fact, CAIMAW National Secretary-Treasurer, F.H. 'Jess' Succamore, has been

involved with the CCU since its beginnings. Consequently, there exists in the CAIMAW fonds a series of records whose provenance can be traced to the CCU executive, yet have been generated within the National Secretary-Treasurer's (CAIMAW) offices. Accordingly, these records have been considered a sous-fonds of the main CAIMAW fonds. Nevertheless, their physical arrangement within the body of the records of CAIMAW has been respected despite their intellectual arrangement ancillary to the CAIMAW fonds. Their description follows the CAIMAW series description.

The bulk of the CAIMAW fonds is comprised of textual records. However, there are a number of audio and video cassette recordings of various convention proceedings (see series "Conventions" description) as well as a number of photographs.

The CAIMAW office employed a subject-based filing system, which, in effect, distorts the "Correspondence" series - making it appear less complete compared to the amount of correspondence which actually exist. For example, correspondence was systematically inter-filed with their related subject matter, thus correspondence is in fact found throughout the entire fonds, depending on their subject matter, and not restricted solely to the "Correspondence" series.

The CAIMAW fonds is comprised of 10 series and 5 sub-series which constitute the records of the substantive functions of the union. These include, correspondence, National Executive Board minutes and reports, convention reports and proceedings, financial files, strike files, (dead) legal files, various other activity files such as, organizing the unemployed and the campaign against Bill 19 as well as the servicing and organizing files of the staff representatives with affiliated locals.

Fonds Description

Title: Canadian Association of Industrial, Mechanical, and Allied Workers (CAIMAW) Fonds, Addendum #1.

Dates of Creation: 1975-1992.

Physical description: 56 cm.

Administrative history note: The original accession of the CAIMAW fonds contains material with distinct series for CAIMAW and a sous-fond for the executive council of the Canadian Confederation of Unions (CCU). This was because the two agencies worked out of the same office but created separate records. With the current addendum however, the files contain records relating to both organization's participation in external conferences, committees and other bodies. Thus, many of the files are intermingled with items from CAIMAW and the CCU. Additionally, many of the records were written or received by Cathy Walker, who held executive positions in both organizations concurrently. For these reasons, the series contained in this accrual have been considered part of the CAIMAW fonds rather than the CCU sous-fonds.

Scope and Content: This addendum consists of records related to CAIMAW's participation in external committees, conferences, and other organizations. Much of the material documents the union's involvement in issues such as occupational health and safety, workers' disability rights and unemployment insurance. There is also a significant correspondence between the CCU's vice-president and the prominent labour-law academic Terry Ison. Another series documents the union's liaisons with international unions and contains important material on a tour that leading members of CAIMAW and the Canadian Confederation of Unions (CCU) made to Nicaragua during that country's Sandanista period. The material was created primarily during the 1980s in CAIMAW and the CCU's Vancouver office.

Arrangement: Original order has been maintained.

Immediate Source of Acquisition: Transferred from the custody of the Canadian Auto Workers (CAW) in 2006. CAW is the successor organization to CAIMAW.

Source of Supplied Title: Based on contents of the fonds.

Series Description

Title: Submissions, Conferences, Secondary series.

Extent: 40 cm approx.

Dates: 1975-1992.

Scope and Content: This series contains memoranda, notes, minutes, correspondence, reports and numerous drafts of submissions for conferences. The files contain documents related to occupational health and safety, worker's disability rights and unemployment insurance and were arranged alphabetically by their creator.

Title: Other Countries series.

Extent: 9cm approx.

Dates: 1975-1992.

Scope and Content: Consists of records pertaining to the union's involvement with the international labour movement. Records of the union's involvement in the Trade Union Group (TUG) predominate within this series. The TUG was a BC-based coalition that sought to build links and solidarity with trade unions in Nicaragua during the Sandinista period. Included in this series is a file which contains journals and other material related to the CCU and CAIMAW tour of Nicaragua in 1986.
