## The Leon J. Ladner Papers Inventory

#### Introduction:

The papers of Leon Johnson Ladner, QC, a prominent Vancouver lawyer and federal politician, were donated to the Special Collections Division of the Library of the University of British Columbia by Mr. Ladner on 23 March, 1972. The papers encompass the period 1915–1969, but the bulk of the collection covers the period from about 1950 to 1969. Included is a variety of material dealing with the Columbia River Power question, and the Royal Commission on Energy (1957–58).

## Biographical Sketch:

Lean Johnson Ladner was born in Ladner, British Columbia, on 29 November, 1884, the son of Thomas E. and Minnie (Parr) Ladner. It Ladner was educated at schools in New Westminster, and later at the Unversity of Toronto, where he received a B.A (1907) and an LLB (1909). After articling with Sir Charles Hibbert Tupper, he was admitted to the British Columbia bar in 1910; in that same year, he was appointed the Honourary Counsel for Belgium for

British Columbia. He travelled through Europe 1910-11, where he met and later married his wife, Jeanne Lantzius, in April, 1912. He returned to B.C. later that year and began to practice law.

Mr Ladner was elected to the House of Commons as the Liberal-Conservative member for Vancouver South in 1921, and was reelected in 1925 and 1926 before being defeated in the 1930 election. During his legislatives career, Mr. Ladner was involved in the debate over Western Canadian freight rates, and was instrumental in the establishment of the Bank of Canada.

After his defeat in 1930, Mr Ladner returned to private law practice, founding the firm of Ladner, Carmichael & Downs. He remained extremely active in politics, both at the federal and provincial level. He was heavily involved in the debate over the potential diversion of the Columbia River in the mid and late 1950s, when he delivered numerous speeches across the country on the subject. Eventually, he was responsible for drafting those portions of Prime Minister John G. Diefenbaker's speeches which dealt with the Columbia River and eventually became federal dovernment policy. In 1957, in recognition of his interests, Mr Ladner was invited to become a member of the Royal Commission on Energy (the Borden Commission). He sat on the Commission for one and a half years and worked on the committee recommendation for the establishment of the National Energy Board.

Throughout his life, Mr Ladner maintained extensive ties to the University of British Columbia. He was an original member of the Convocation of the University held in Victoria in 1912. On 1 March, 1955, he was appointed to the Senate where he served until 1963. At the same time, he was the Senate representative to the Eoord of Governors (1957-63). In 1963, he was appointed as the Government's representative to the Board and served an additional three year term. During his tenure, he served as a key member of the Finance Committee and was largely responsible for the establishment of International House. In 1969, he donated to the University the funds necessary to build the Clock Tower, which stands in front of Main Library; as well, he endowed a series of

scholarships. Mr Ladner also lectured at the UBC Law School for ten years on the subject of income tax.

After his retirement, Mr Ladner published a book about his pioneering family who established the communities of Ladner and Delta, entitled <u>The Ladners of Ladner: By Cavered Wagon to the Welfare State</u> (1972). He died on 12 April, 1978.

#### Scope and Content Note:

The Ladner Papers, consisting of correspondence, newspaper clippings, briefs and submissions, pamphlets, maps, speeches and addresses, copies of legislation, personal notes, memorabilia and research (subject) files, span the years 1915-1969. The bulk of the collection, however, covers the period from about 1950 to 1969 and reflects Mr Ladner's involvement in the federal Progressive Conservative Party, the question of Columbia River Power, and the Royal Commission on Energy. This collection does not contain all of Mr Ladner's papers; a further 8 m. can be found at the City of Vancouver Archives.

The collection is divided into four main subgroups as follows:

Private individual (1915-1969)

Member of Parliament (1921-30)

Lawyer, consultant on Columbia River Power (ca 1930-60)

Member, Royal Commission on Energy (1957-58)

During the 1950s and 1960s, Mr. Ladner carried on an extensive correspondence with many key figures in the Progressive Conservative Party, including the Right Honourable John G. Diefenbaker, and Hon. George Drew. This correspondence makes up the bulk of the political material found within the collection.

At the same time, Mr Ladner was compiling a series of large informational files on the question of Columbia River power. These files, containing pamphlets, correspondence, various maps, annual reports from power companies, personal notes, speeches and addresses and newspaper clippings are a vast, if an internally

unorganized source of information on the whole Columbia River power question. Scattered throughout is also a significant amount of information on dams in the United States, particularly in the Pacific Northwest region. Some of the correspondents include A.G.L McNaughton, chairman of the International Joint Commission on the Columbia River, as well as prominent provincial figures such as A.E. (Bal) Grauer, W.A.C Bennett, and W.C. Mainwaring. These files served as the background for Mr Ladner's series of speeches on the subject which he gave across Canada and the Pacific Northwest from 1956 to ca. 1963.

Most of the collection (139 of 208 items) consists of material on the Royal Commission on Energy (the Borden Commission), consisting mainly of Mr Ladner's personal copies of the submissions made to the Commission. Included is information relating to the drafting of the various Commission reports, as well as background material on energy resources in general.

Other significant material in the collection includes individual files on the campaign to increase federal judges' salaries (1928-29), the establishment of the Bank of Canada (1923-24), the debate over Western Canadian freight rates (1925-29), and the movement to excludes Asiatics from British Columbia (1921-35).
