INTRODUCTION

The Solidarity Coalition was formed August 3, 1983 by a group of concerned citizens from all walks of life who wanted to oppose the Social Credit Party of B.C., specifically its policy of "restraint," by voicing a unified protest.

Out of this coalition came The People's Commission For Social and Economic Policy Alternatives. Composed of four commissioners, the People's commission travelled B.C. for three months in 1983 (Oct.-- Dec.) holding public meetings, collecting briefs and hearing grievances from individuals and organizations. Its aim was to disseminate information, provide people all over B.C. with a readily available forum, and thus to create a popular opposition.

The files contain, mainly, the briefs and grievances which the People's Commission collected, as well as newspaper clippings, editorials, and pamphlets dealing with social and economic issues. There are also photographs and hundreds of signed petitions in addition to transcripts of the meetings and public hearings.

These files are arranged as they were accessioned, by place and issue: Labour, Kelowna; Social Services, Nanaimo; Vancouver Hearing; etc. as well as by issue alone.
