AUCE/ SORWUC JOINT SHOP STEWARD SEMINAR

OCTOBER 16th 1977

a letter was sent to the secretaries of each local outlining the philosophy and 'birth' of the AUCE/SORWUC committee. Dated 11 July 77 sent by Melody Rudd, then sec./treas. of auce provincial.

basically - the 4th annual auce convention recommendations were as follows:

- that the auce/sorwuc committee should include the Provincial full-time person and at least one rep. from all locals of Auce.

-that auce and sorwuc continue to worlto organise unorganised workers and promote union democracy.

- that this cttee. discuss the possibilities of merger, affiliation or other formal joint structures with sorwuc such that auce members may have more direct input and control on the organisa-tion of unorganised workers by this cmmttee.

- that the auce/sorwuc cttee. be authorised to organise a joint steward seminar and other joint educational activities.

The first meeting was July 8th, and another held later in August. Sheila Perret attended a5 rep from local #4.

Two other planning meetings ahve been held and another is scheduled for tonight Sept. 21st. I am unable to attend. Anyone wishing to go and take part in the essential activity please let me know and I will forward your names to the provincial sec./treas. Judy Wright.

The seminar will be held at CapCollege , all day on the 16th Oct. 9.00 to 5.00pm. Lunch will be provided.

The day will be organised around the following activities:

Affiliation report from the joint cttee.
What is a steward.
A film will be shown - "Union Maid"
Lunch from 12.00 to 1.00pm

The lower mainland folks of both organisations will conduct the first 2 hours of the seminar. Tonight's meeting will be to plan those first two hours.

In the afternoon each local will be called upon to present a grievance procedure, either by role-play or simply a good explanation of the contract procedure that local must follow for a grievance.

Hopefully a video will be made of the conference so that each local can refer to it when staging its own shop steward seminar.
