- 3. Secretary-Treasurer's report
 Patricia presented the list of cheques written for September-November and
 answered questions concerning it.
 Moved by Patricia House Seconded by Suzan Zagar
 THAT THE EXECUTIVE AUTHORIZE PAYMENT OF FAIRLEIGH WETTIG'S OVERTIME AS
 PRESENTED.
 The motion was CARRIED.

Patricia reported that she would prepare a financial report for the membership for the January meeting. It was decided that the January membership meeting would allow a large amount of time for finances, as soon we will need the time for contract matters.

- 4. Referendum
 Discussion of when we could get short term leave for Wendy Osborne to prepare ballots (Suzan will be on vacation). Decided to try to get leave for Dec. 9 and have the deadline for return of ballots be Dec. 23.

 It was asked if there was a problem with Fairleigh holding two Executive positions if she is elected. Although the Executive has been under the impression that there was a by-law prohibiting holding more than one position at a time, nothing could be found when the question was researched in the by-laws, constitution, or minutes that established that policy. Therefore, it was concluded that there is nothing stopping someone from holding two positions.
- 5. Discipline Motion from November 10 membership meeting
 The legal opinion was presented and there was considerable discussion, including
 the practical logistics of how to compile a complete list of everyone who went
 across picket lines and to be certain it was accurate.
 Fairleigh suggested the Trustees make a motion to the membership that we adopt
 the Provincial Constitution until such time as we become part of some other
 union.
 There was concern expressed that if we don't take action this time members
 who crossed will not respect picket lines in the future. In addition the
 Executive was given a clear directive from the membership to make this
 assessment. It was the consensus that the Executive should proceed.

We will get a list of members who crossed and verify that each one should be on the list. Then publish the list in the newsletter saying charges are

There was a program of action passed that if the money saved from the
teachers salaries was not put back into the school system there would
be strong action from Solidarity again.

There was also a motion passed that the Fed. Executive Council investigate
why non-affiliates have been kept out of the Fed.

Fairleigh reported that the 96.1 had been filed on the Statutory holidays. Several ongoing cases: Joyce Diggins has been off almost 6 months, we have encouraged the University to fill the job; as yet undecided what will happen to Joyce.

Murray Wynn--has met with the lawyer, the arbitration has been set for January. Rona Broverman--case has been dropped.

Mila Fialova--the committee has decided not to grieve but protested the handling of the suspension.

of the suspension. Ted explained that we have been dickering over arbitrators for the reclassifications.

The research is being prepared for the arbitrations.

Donella Oliver has two cases: Should her job be considered a sessional anomaly?

Grievance re: rejection for Admin. Clerk job in Housing.

Doreen Helm--turned down for Anaestheology Sec. IV, but won't grieve 32 temporary LAIIs are going to be covered by a letter of agreement to be sent

out to them re: being put on the recall list.

Shaun Tanasee--possible exemption from AUCE; Fairleigh and Shirley are still investigating and will make a recommendation to Executive for their consideration. Ted has been working on the exclusions list and suggested it be brought to the

Executive for consideration. This was accepted.

Ted reported on the new University policy with regard to reclassifications i.e. the money must now come out of the dept.'s budget or the job will be downgraded. Previously the money has come from a different general account outside of dept.'s budget.

Our lawyer has filed an appeal of the LRB decision re: Nov.8-10 protest.

- 11. Kitti's report on President's statement today
 Pederson said that no final decision has been made yet by the govt on
 the University's budget and so no final decision made at the Univ. yet.
 Best the University can hope for is no decrease; worst expectation may be 5%
 decrease in the budget....Univ. has drawn up plans for each option that
 appears likely
 Plans will address:

increase in tuition

cutting down on duplication of programmes between the universities in the province layoffs, reduction of support units, external grants, early retirements, etc. Deficit budgetting would require special legislation as Universities are not now allowed any deficit carry over

A committee is investigating and will report back to the President by the end of Feb/84 with the intent of having plans drawn up to deal with any cutbacks by the beginning of the fiscal year.

Pederson's speech will be published in UBC reports.

Fairleigh reported that the Campus Community Alliance will be drawing up a brief with their suggestions....this will be given to the University
