The meeting was called to order at 7:40 p.m. with Nancy Wiggs in the Chair.

Local 1 Report

Sheila Rowswell reported that the first general membership meeting since the last Provincial Executive meeting will be held on Thursday, January 14 1982. It is possible that the motion to secede from AUCE Provincial will be on the floor for discussion.

Sheila also reported that the preparations and research for the upcoming negotiations are proceeding well-the Local sent out a questionnaire to the membership to help determine the kinds of issues that the members are prepared to back.

Local 1 received a letter from the Labour Relations Board stating that AUCE members are not a part of the application submitted by the Hospital Employees Union in their current attempt to gain a certification from CUPE 116.

Local 1 has recently become aware of a variance issued by the Workers' Compensation Board, exempting the university from certain provisions of the Act. The variance was likely issued before the existence of the union, and the matter is currently being investigated by the union.

Local 1 has a new executive: President - Irene McIntyre, Vice-president - Suzan Zagar, Secretary-Treasurer - Patricia House, Membership Secretary - Wendy Lymer, Trustees - Sharon Newman & Joyce Diggins, Union Co-ordinator - Wendy Bice, Union Organizer - Carole Cameron, Grievance Cmte. Chair - Ted Byrne, Contract Cmte. Chair - Murray Adams, Provincial Rep. - Sheila Rowswell.

Nancy Wiggs stated that particularly in the election of the Vice-president, the result was interesting since S. Zagar ran on a clear pro-CUPE ballot. K. Cheema, the pro-independent candidate lost by only 24 votes. Further, Joyce Diggins and Irene McIntyre, both opposed to a merger with CUPE won their bids for office.

Local 1 passed a motion of support for the T.A. union, CUPE 2278, in their attempts to obtain a contract. The mediator has now booked out of the dispute, and CUPE 2278 is holding a one day strike on January 22, 1982. No motions were possible at this meeting of the Provincial Executive, due to a lack of quorum, however will be allowed on Saturday, January 9th.

Lid Strand reported on a conversation with Darlene Bailey, the union's representative on the President's Advisory Committee on Health & Safety. There is a sense of frustration since the committee has no power to do anything about some of appalling conditions that exist at the university.

#### Local 4 Report

This is an unofficial report by Sheila Perret, a member of the Local, since there were no Provincial Representatives from Local 4 present. 95 members voted to secede from AUCE in a referendum ballot, with 12 voting against and 3 spoiled ballots. The Executive is now circulating a petition, as per the Constitution. The elections will take place in February/March.

It was noted that the Provincial received Local 4's per capita for October 1981.

The next general membership meeting will be on January 21, 1982. The new medical doctor for Capilano College will be the guest speaker.

#### Local 5 Report

See written report attached to minutes.

The written report was supplemented. The management consultant firm that was called in to study labour relations at the College has submitted its report to the College Board. The union has not seen a copy as yet, but it appears that the Board may not release the report in its entirety. The only recommendations that the union is aware of is that the consultants suggested that informal meetings between the unions and management would be helpful. This recommendation comes as no surprise, since management has always pushed for "friendly" and "one on one" meetings.

#### Local 7 Report

December was spent establishing contacts with the groups that will be in the bargaining unit, such as the lab instructors.

A positions has been created on the Executive, to act as a liason officer.

The Executive of Local 7 was elected December 10, 1981, as follows: President - Kathy Chopik, Vice-president - Janet Laxton, Treasurer - Alan Dutton, Trustees - Richard Kuhn & Alan Howatson, Member At Large - Andy Shand.

The first issue of the G.S.S. Newsletter was published in December. A great deal of space was allowed for reporting on union activity.

On January 6, 1982, AUCE Local 7 initiated a meeting with CUPE 951 (inside workers), since CUPE had expressed hostility towards AUCE. CUPE expressed a concern that AUCE was well known as a militant union, and that this could endanger their "good relationship" with management. However, members of Local 7 were able to convince CUPE to support the organizing drive of the union and further that an article would appear to that effect in CUPE's next newsletter.

Meetings have begun with lawyer C. Askew, regarding the composition of the bargaining unit.

Local 7 also asked for people to be sent to a meeting on Monday January 11, 1982 at 7:30 p.m..

Local 2 Report

Lynne Taylor reported that due to the holiday season, things have been quiet at the local. The first Executive meeting of the new year will be on Wednesday, January 13, 1982 where the Executive will begin organizing for the upcoming dues increase.

Local 6 Report

Jack Gegenberg reported, since there is no Provincial Rep..

Grievances before the Labour Relations Board regarding the university's hiring policies are still continuing. The union won the arbitrability of the cases but has now lost one, where the Board did not agree that an employee was discriminated against in the hiring procedure. The case of a second grievor is still continuing.

The Local is considering a dues increase, the current dues being 1% of the salary.

BUSINESS ARISING FROM MINUTES

B.C. Federation of Labour Convention - Jack Gegenberg reported that several members of AUCE attended, including Star Rosenthal, Sandy Shreve, Anne Sullivan & Lauma Avens. Jack reported that a leaflet was distributed to delegates at the convention, seeking support for AUCE's inclusion into the CLC. This resulted in a delegate speaking in favour, and calling for a change in policy regarding jurisdiction. A motion from the United Food and Commercial Workers calling for "one union-one industry" carried. Another motion calling upon the B.C. Fed./CLC/Labour Councils to work towards allowing non-affiliates in also passed.

AUCE members also lobbied informally, speaking to delegates after the convention in the hospitality suites.

Lid Strand, who also attended the convention, stated that on the surface the convention appeared boring and controlled. However, there existed various behind the scenes lobbying and meetings. He spoke to a member of the Quesnel Labour Council, who supported AUCE's stand. It was clear that the firm lines/hostilities between unions was not as evident in the Interior.

Lauma Avens indicated her concern that the rank and file had no control and no real say at the convention. She further commented on the undemocratic way in which the Executive

conducted the various votes, calling for a voice vote on important issues, in order to ensure that they passed. She also stated that delegates had no prior knowledge of when resolutions from the unions would reach the floor. The Resolutions Committee called out debate on resolution in an arbitrary manner, rather than in a chronological order.

Kyra Guest expressed surprise that a member of the Quesnel Labour Council supported the AUCE position, since the Prince George & District Labour Council gave absolutely no support to the strike of AUCE Local 5, despite a request by the Local.

Convention Minutes - Sheila Perret reported that the minutes were almost finished, and when they were, she would be meeting with Bob Wiseman regarding the constitutional amendments.

Job-Evaluation Report - Nancy Wiggs suggested that this item be struck from this agenda and future agendas, since it had already been settled that the Provincial would cover all copying costs for the JJSERC report.

Union Sisters - Sheila Rowswell stated that this organization has been in existence for approximately 7 months. It is an organization consisting of women in trade unions that meet for dinner about every 4-6 weeks to discuss relevant issues. The next meeting is January 20, 1982, at the Astor Hotel, dinner at 7 p.m., bar at 6 p.m.. The person to call is Pat Crowther, at work 291-3183 and home [REDACTED].

Prioritizing Provincial Support/Involvement - Sheila Perret was concerned that if we supported too many issues actively, we are spreading ourselves too thin.

Sheila Perret reported that three neighbourhood houses, Little Mountain House, South Vancouver Neighbourhood House & Kiwassa, have formed a committee to investigate unionization. They have narrowed it down to CUPE or AUCE, and have a final meeting scheduled for Tuesday, January 12, 1982, where speakers from both unions will address the membership.

The workers are under special contracts from the Ministry of Human Resources and they work with families and children in crisis. They are largely part-time, women workers, earning approximately \$7.00 an hour and have erratic working hours.

One of their greatest problems is the insecurity of their funding from the government which is on a year to year basis.

A lengthy discussion followed, centered principally on the concerns of what the workers expectations are of unionization, particularly in view of the funding insecurity. Executive members expressed the concern that in the event of a discontinued fund, a union can do very little, except perhaps to build public support. Also arising out of the discussion was the issue of increasing our jurisdiction and overlapping the jurisdiction of SORWUC.

## SECRETARY TREASURER'S REPORT

The last month in the Provincial Office has been a busy one. The major part of my time has been spent on implementing our motions re:an "umbrella alliance committee" and the related articles dealing with the Bennett Compensation Stabilisation Program.

I have already sent the Provincial Executive members copies of the minutes and related information about the Defend Educational Services Coalition (DESC) that has been formed. I have also provided copies of the latest materials that DESC has put out. We are now faced with having to make difficult decisions about our participation and level of participation in DESC.

A structure has been developed for DESC, consisting of a Steering Committee (the Spokes person, Liason Person and Corresponding Secretary), a News Bulletin (Desc Updates) and proposals for publicity and research. A Proposed budget of \$100,000 has been drawn up and it is recomended that each member group contribute \$2.00 per full time Equivalent Member (for AUCE approximately \$5,000).

Although the meetings have been interesting they have been time consuming and I feel that it is important that more than one representative from AUCE participate. I am recomending that this Executive approve an Executive Sub-Committee of 3 members to attend and participate in the activities of DESC.

I will present a more detailed report as a separate item on this agenda.

### COPIER REPAIRS

The Monday following the Executive Meeting, Copytron was contracting about implementing our decision to repair the Copier. A replacement machine is currently in the Provincial Office. Our machine has not been returned yet and upon asking Copytron they could not provide a firm date. I talked to the Sales Manager on Friday and he informed me that we are generally charged for the transportation of any replacement machine but not for the length of time that we have it.

### OFFICE HELP

After informing members that part time work was available in the Provincial Office and discussing the work and hours with those who indicated interest - I recomended that Michele Valiquet be given 10 hours a week and that Sheila Perret be given 5 hours a week. I have found the additional help useful in getting backlogs of work caught up and in reducing the sense of isolation that I have found working in this office.

### TIME MANAGEMENT COURSE

I have registered for a Time Management Course being offered by BCIT at the Downtown Education Centre. The course will consist of 7 Monday evenings from 5 to 7:15 pm and will cost \$48.00.

I have also inquired into a Time Management course offered by the Federal Business Development Bank. They offer three hour courses, throughout the regional district, the cost of which is \$20.00.

### YEAR END AUDIT

March 31st is our Fiscal year end. Generally the books are pulled together and the loose ends are tied up before bringing them to the Auditor's for verification. The more pulling together that can be done before they are presented to the Auditor - the smaller the Auditor's fees will be.

I am going to recomend that Sheila Perret be hired for 35 hours in order to assist with the preparation of the books.

#### NEWSLETTER

The Provincial Newsletter has not been finished yet. It could go out within one week provided that concentrated energy was put into it. The Bennett Compensation Stabilisation Program, the creation of DESC and the activities that it is planning, Local Reports and other recent developments means that some of the material in it must be updated - while new articles have to be written. It is important that the newsletter be put out soon so that our membership can be informed about our activities and about how they are going to be affected by policies like the Compensation Stabilisation Program.

#### SORWUC BILL

The bill from SORWUC Local One is still outstanding.

#### LABOUR MINISTRY INTERFERENCE

The Prince George LRB Decision has been duplicated but the covering letter/press release has not been written yet. It will be done by next Friday.
