3) PRESIDENT'S REPORT

That the Four Executive members who sent a letter to the Trade Union Research Bureau be instructed by the membership to rescind the letter and cease any further actions pertaining to this matter.

Explanation: Four Executive members had asked the Trade Union Research Bureau to cease all work pertaining to an arbitration to be held May 8th, 1989, as a result of a motion passed at an Executive meeting on April 12, 1989 which were:

1. MOVED:Ellis/SECONDED:Claybo

That we not retain TURB for arbitration, that we use Joe, Rosanne Hood, or CUPE: and that we retain TURB as consultants if required by counsel, pending result of legal opinion.

2. MOVED:Claybo/SECONDED:Ellis That we request TURB to hold off on any more research or investigation until notified.

That Rosanne Hood get legal opinion in writing by Tuesday, April 18, from CUPE whether the Grievance Committee has the right to go to outside counsel without approval of the executive and/or the membership and whether the contract can be broken. CARRIED

Shirley Irvine passed the Chair and explained the background leading up to the grievance committees' motion. She reassumed the chair and opened the Floor for debate. She first gave opportunity for each of the four Executive members to explain why they supported the motions passed at the April 12, Executive meeting.

Grievance Committee Motion was CARRIED. The membership was in favour of having the Trade Union Research Bureau continue to handle the arbitration.
