#### SECTION O Discipline

Any number of members of the Local Association shall have the right to prefer charges against any other member of the Local Association, according to Section 14 of the Provincial Association Constitution and the following provisions. Charges can be preferred against any member who:

(g) Continues to work for the employer while another union is on strike and is picketing the member's place of work. The executive of the Local will notify the employer that such picketing is bona-fide in accordance with article 17 of the collective agreement and shall call a meeting of the membership as soon as possible to discuss the situation.

#### Contract Committee's report 4.

There was some discussion explaining two proposals that have been received by the committee from the membership. The first would give people on the recall list first refusal of jobs in the lower classifications in order of Membership Meeting -- April 26, 1984 -- Page two

seniority. The other proposal suggests the Union try and negotiate downward bumping. The committee has considered both options and said that the downward bumping idea opens up a considerable number of clauses of the contract. Because of that, the committee asked for some direction from the membership. It was decided to tell the University at the table that the Union intends to discuss the layoff/involuntary transfer procedure. The membership wanted more detailed information about what clauses would be opened up and it was agreed that the whole matter would be brought back to a future two hour membership meeting.

The meeting was adjourned.
