To Collectors of Customs and Excise and others concerned:

MARKING OF IMPORTED GOODS

Referring to Memorandum Series D No. 1, you are advised that by Order in Council (P.C. 308) dated the 9th February, 1939, the following descriptions or classes of goods were added to the list of articles required to be marked with an indication of the country of origin on importation into Canada, under Section 16 of the Customs Tariff, effective on and after the first day of May, 1939:—

DESCRIPTIONS OR CLASSES OF GOODS

- 4. Gloves and Mitts of all kinds.

Regulations

Each glove must be marked, except where pairs are firmly attached, when marking on one glove of each pair will be satisfactory. Marking must be effected by printing or stamping or by means of a woven or printed label sewn or otherwise strongly attached to the inside of the glove. With respect to work gloves of woven fabric, such labels will not be accepted if they are located more than one inch from the edge of the wrist band.

- 13. Chinaware and Porcelainware (not including sanitary or toiletware), decorated or undecorated, as follows:—
 - (i) Articles commonly used in connection with the serving of food or drink, or intended or designed for household use for ornamental or decorative purposes;
 - (ii) Kitchenware and utensils;
 - (iii) Heraldic and Souvenir ware.

- 15. Tableware and decorative household articles of semi-porcelain, white granite, ironstone, earthenware, stoneware or pottery.

27. Animal Traps.

Regulations

The indication of the country of origin must be permanently marked on each article, either by printing or die stamping.

28. Metal knives, forks and spoons for table or household use (not including articles of sterling or silver-plate).

Regulations

The indication of the country of origin must be permanently marked on each article, either by die stamping or blind embossing.

29. Thermometers of all kinds.

Regulations

The indication of the country of origin must be permanently marked on each article, either by printing, die stamping or blind embossing.

By the same Order, the following Orders in Council, the provisions of which are continued in amended form, were cancelled, namely:—

Those portions of Orders in Council P.C. 2505 of the 11th October, 1934; P.C. 2470 of the 14th August, 1935; and P.C. 1103 of the 26th July, 1938, relating to chinaware and porcelainware, tableware, and rubber gloves and work gloves of woven fabric.
