"AUCE Local One hereby charges AUCE Local Five under section 19(F) of the Provincial Constitution in that it affiliated to the Canadian Confederation of Unions in contravention of AUCE's policy decision to affiliate intact to the Canadian Labour Congress by lobbying the Canadian Labour Congress. Further, it is the position of AUCE Local One that a reprimand is totally inadequate and inappropriate given the severity of the situation. We urge that a hearing be held on the matter as soon as possible."
