2. AMENDMENTS TO THE PROVINCIAL CONSTITUTION:

(#1) SECTION 2: OBJECTIVES AS IT NOW READS -

The objectives of this Provincial Constitution shall be:

A. to bring about fair wage standards and to assure uniform job classification with equal pay for comparable work for all employees, regardless of sex, sexual orientation, age, marital status, color, race, religious or political beliefs, national origin, or whether or not she/he has children.

"...physical disability unrelated to job performance, previous and current psychiatric or psychotherapeutic treatment unrelated to job performance..."

PHYSICAL PLANNING COMMITTEE

The Physical Planning Committee met April 18th. It was noted that a quorum was not present so the members agreed to an informal meeting with any motions being ratified at the next meeting.

The following items were discussed:

STAFF OFFICE: NF #17 has been identified as a Staff Association office, effective June 1st, 1978 for a one year term on loan from Careers.

NORTH CAMPUS QUADRANGLE: A request was put before the meeting from the Health and Safety Committee to discuss a change in the configuration of the North Campus grassed quadrangle in order to prevent games being played on this area. Cathy Zuest was a guest at our meeting to explain the rationale behind this request. After several suggestions it was resolved that PPC would recommend to the Principal that the North Campus quadrangle be changed so as to accomodate more student seating and related activity so as to prevent the playing of active games. This may be in the form of additional gravel and picnic tables.

CARPET IN THE PIT AREA OF THE CAFETHEATRE: It was reported to the committee that the carpet on the tiers leading down to the Pit in the Cafetheatre would be torn up and replaced with linoleum tile. It was noted that this type of material covering the tiers would discourage and hamper the use of these steps as a seating area. Therefore the committee recommended that the carpet be replaced with another carpeting which is of a better quality and allows for a minimum amount of maintenance.

COLLEGE COUNCIL REPORT

Two items of interest:

- (1) Because of Dr. Paul Gallagher's presentation to Council expressing the views of P.A.C. and other college constituents, Council approved the Principal's plan for an open search committee for the third Deanship. A.U.C.E. has been invited to have 2 members on this search committee.
- (2) Capilano College received a 6.8% increase in their budget to cover inflation and a 7.56% increase for instructional growth and if the total budget is passed by the Legislature, Capilano College will receive a total of \$7,706,000.00.

HEALTH AND SAFETY COMMITTEE REPORT

The Principal has approved the time off for first aid certificate holders to attend upgrading seminars with the Health Nurse on a regular basis.

A special parking stall marked 'Health Nurse Only' will soon be erected on the North Campus across from the Cafeteria.

The Principal has advised that the Committee recommendation for purchase of some air cooling/circulating devices for classrooms in portables has been received. Capital request for money for this item has been forwarded to Victoria, but we probably won't hear from them until late summer. Another long hot summer ahead in the portables.

As a final solution to the problem of game playing on the North Campus quadrangle, picnic benches will be added to the grassed area. The decision not to allow game playing in the area was more a result of the Physical Planning Committee recommendation that the turf would not stand the wear, than the safety hazard it posed.

A.U.C.E./P.A.C. REPORT
