IN ACCORDANCE WITH SECTION 1211) OF THE AUCE PROVINCIAL CONSTITUTION, 'VACANCIES IN PROVINCIAL EXECUTIVE POSTITIONS' -

A. IN THE EVENT OF A VACANCY FOR ANY REASON IN ANY OF THE PROV-INCIAL EXECUTIVE OFFICES ELECTED AT LARGE, THE FOLLOWING SHALL OCCUR:

11) IF THE VACANCY OCCURS FOUR (4) MONTHS OR LONGER BEFORE THE NEXT ANNUAL CONVENTION, THE PROVINCIAL EXECUTIVE SHALL PUBLISH NOTICE OF THE SAME IN THE PROVINCIAL NEWSLETTER. IT SHALL CALL FOR NOMINATIONS TO FILL THE POSITION, AND PUBLISH THE DATE UPON WHICH THE NOMINATIONS SHALL BE CLOSED. SUCH DATE SHALL BE AT LEAST TWO WEEKS AFTER THE NOTICE OF VACANCY IS PUBLISHED. A REFERENDUM BALLOT SHALL THEN BE CONDUCTED AS PER SECTION 8 D.'
