Whereas at a Court holden at *Victoria* on the *fifteenth* day of *July* A.D. 186*2*, the above-named plaintiff by the judgment of the said Court, in a certain suit wherein the said Court had jurisdiction, recovered against the above-named defendant the sum of *£ 4. 2- 7-* for his debt, and the sum of *£ 4. 18- 5-* the costs of the said suit, amounting together to the sum of *Eight Pounds sixteen Shillings* and thereupon it was then and there ordered by the said Court, that the defendant should pay the same to the Registrar of the Court, at his office, on or before the *twentieth* day of *August* 186*2*

And whereas the defendant not having paid the said sum, pursuant to the said order, a summons was, upon the application of the plaintiff, duly issued from and out of the said Court against the defendant, by which said summons the defendant was required to appear at the said *Court*

at *Victoria* on the *21st* day of *October*, One thousand eight hundred and *thirty six*, to answer such questions as might be put to him touching his estate and effects, and the manner and circumstances under which he contracted the said debt

, which was the subject of the action in which the said judgment was obtained against him, and as to the means and expectation he then had, and as to the property and means he still had of discharging the said debt, and as to the disposal he had made of any property.

And whereas the defendant having duly appeared at the said Court pursuant to the said summons, was examined touching the above matters.

And whereas it appeared upon such examination, to the satisfaction of the Judge of the said Court, that *The defendant should pay two pounds per month* and thereupon

it was ordered by the said Judge that the defendant should be committed for the term of *Six* days to the *common Gaol*

according to the form of the statute in that case made and provided, or until he should be discharged by due course of law. *in default of such monthly payments - and whereas three pounds nine shillings are yet due and unpaid by said defendant upon said judgment.*

These are therefore to the Bailiff, Bailiffs, and others,
to take the defendant and to deliver him to the Governor of
the said Governor
are hereby required to receive the defendant and him safely to keep in the
said term of six days
from the arrest under this warrant, or until he shall be sooner discharged by due
course of law.
