AS WE HAVE WITNESSED CONSIDERABLE POLICE INVOLVEMENT AND PROVOCATION IN THIS AND OTHER DISPUTES (CAIMAN AT ENDAKO; RETAIL WHOLESALE DEPARTMENT STORE UNION AT THE ADAMS LABORATORY IN SURREY; SORNUC AT THE MUCKAMUCK RESTAURANT TO NAME A FEW) WE SEEK YOUR SUPPORT.
