  - iv) THE UNION'S REPRESENTATIVE TO THE UNIVERSITY'S HEALTH AND SAFETY COMMITTEE SHALL BE ELECTED FROM THE WORKING CONDITIONS COMMITTEE.
  - v) THAT THE WORKING CONDITIONS COMMITTEE REPRESENTATIVE TO THE UNIVERSITY'S HEALTH AND SAFETY COMMITTEE SUPPLY THAT COMMITTEE'S MINUTES TO THE EXECUTIVE.
