A special membership meeting to consider the second wage offer proposed by The University was held by AUCE Local 1 on Monday June 22, 1974 in Hebb Theatre 12:00 to 2:00 P.M., with Jean Rands in the Chair.

The Chairman explained that a series of motions was to be presented by the Contract Committee, relevant to the detailed information circulated on the special leaflet. The leaflet is attached as an addendum to these minutes.

Betty Vinson gave a concise and informative outline of the issues and The University's offer.
