#### 1ST PROVINCIAL CONVENTION - RULES OF ORDER

#### Quorum

As provided in the Constitution, a quorum shall be a majority of the registered delegates.

#### Motions

- (a) All motions must have seconders, or will fail "for lack of a seconder."
- (b) Long or complicated motions should be written out and handed to the Secretary.
- (c) When making or speaking for or against a motion, please rise and give your name and Local and indicate whether speaking for or against the motion.
- (d) Should discussion of a particular motion prove lengthy, it may be necessary for the chair to limit discussion.

#### Amendments

- (a) An amendment is a proposed change in the motion which is being debated. Each amendment must be moved and seconded. An amendment must involve a change not in contradiction to the main point of the motion. If the intent is to change the main point of the motion, the motion should be defeated and a new motion moved.
- (b) A vote on an amendment is taken before the vote on the main motion. Should the meeting be in favour of the amendment, any further discussion and the final vote will be on "the motion as amended."

# Tabling Motions

It should be noted that tabling a motion at this Convention will have the effect of delaying further discussion until the next Convention in the spring of 1975.

## Observers at the Convention

AUCE members (whether members of Locals or Headquarters members) may have voice but no vote, and may not make motions or second motions.
