- 5) Prospective pamphlet distributed and discussed. Moved by Mike Howlett and Seconded by Kevin Annett that \$100 be allocated to the Education Committee to produce the third information pamphlet.

6) Finances of Alliance discussed. Moved by Ted Bryne and seconded by John Black that All groups belonging to the Alliance be asked to donate additional funds to the Alliance

7) Strike HQ discussed. Lutheran Centre to be used to co-ordinate activities. Moved by Lisa Hebert and Seconded by Ted Byrne that Paul Richter be delegated to investigate the possibility of installing extra phone lines at the Lutheran Centre.

8) Picket lines and strike strategy dicsussed. It was decided to concentrate on a strategy involving picketing as many campus entrance gates as possible. Priority will be given to bus entrances (on Map #'s 1,3) and then to parking lots (#'s 8,9,11,2,4) and then to residences and incidental entrances (#'s 10, VST, 6,7). If possible these pickets would operate on a 24 hour basis with 3 four hour shifts of 10 people between 7am and 7 pm and 3 four hour shifts or 4 people between 7 pm and 7am. It was moved by Mike Howlett and Seconded by Horacio de la Cueva that a strike committee be established composed of one person from each union and community group, in the Alliance and provided with an initial \$50 budget.

9) Essential Services were discussed. It was moved by Lisa Hebert and seconded by George Hermanson that the following essential zervices be recognized by the Alliance:

Residences (utalizing ID passes - and allowing skeleton staff to man kitchens with potential volunteer student help)
Includes: Totem, Vanier, VST, Corey wall, and St Marks

Fire and Police services
Hospitals until 18th when it will be skeleton
Student Fealth Services
Emergency Student Loans (to be co-ordinated off campus by AMS)

Pastoral care in emergency situations

Maintenance of Tive material (passes to be issued

by strike committee)

and furthur that the strike committee should continue to evaluate anddesignate essential services as they arise

10) After report by Paul Richter on phone costs it was moved by Mike Howlett and seconded by John Black that the Alliance authorize the installation of one line with the number of phones to be determined pending approval of costs by other UBC unions, in the Lutheran centre.
