

PROVINCIAL REPORT

This year's Convention took place May 27-28 at Capilano College. It was well attended and most delegates found it interesting and informative. The Secretary-Treasurer reported on the events taking place at the Provincial level through the year. Most important it was felt, was the shop stewards seminar organized at the College in Prince George. Consequently, Prince George was well attended at the Convention and some of their people are standing for Table Officers. It also indicates that other areas are taking the leadership role from UBC.

At the Convention, we heard the plight of other unions: SORWUC reported on their year's organizing which has been very busy indeed with new contracts negotiated in a number of offices. Their bank drive will, it appears, really start rolling soom with a strong hint of job action aimed at the banks. In order to support SORWUC in their very necessary role of organizing underpaid women workers, the AUCE Provincial voted to loan them ten thousand dollars. Good Luck SORWUC.

A second union visited the Convention. That was UFAWU, or the Fishermen and Allied Workers Union. It seems that the Federal Government is really attacking this particular union. The government does not want to permit the Fishermen to have their own union. Fish plant owners have co-opted the government to take their side in the dispute in order to pay the fishermen very low prices for their fish. We feel this union really needs our help, so there are buttons and stickers publicizing their cause in the Union Office for those interested.

Financial report of the Provincial reveals a sound financial position. Income for the year was \$48,487. Expenditures were \$38,599 and therefore, excess of revenue over expenditure was \$9,888. The total assets of the Provincial now stand at a healthy \$23,135. The Strike Fund stands at \$20,659.

The delegates voted on a new voting wrinkle which you should all be aware of; that is, from now on when voting for Provincial Officers you must now say YES or NO for candidates voted in by acclamation. The referendum vote for Provincial Officers will be happening within the next month. You must consider the following people who are running: procedure. The Wedgham Prince Coerce





Dear Membership,

Our Union has always strived for equality within it's structure. I never thought this would be put in jeopardy until the assessment arose re: the operating engineers strike. I don't think most people have realized the substantial difference a deduction of \$20.00 makes in these days of high inflation to someone who takes home \$700/month, as compared to someone who can take home as much as \$1200/month.

<u>i.e</u>: After all my bills are paid each month I allow myself (and that's without any savings, as I live from payday to payday) \$20.00 per week to spend! I guess I'll have to go bankrupt so my fellow workers are treated fairly even though I'm not.

As percentage is far too complicated, I suggest the <u>only</u> fair alternative: A person making \$1200/month must make approximately \$40-50/day (this may be an exaggeration - correct me if I'm wrong) while someone earning \$700/month will make \$30-40/day. Why not just deduct 1/2 days pay from each person in our union? Therefore, someone making the larger sum pays \$20-25 and the person making the lower wage pays \$15-20. Also, if everyone forfeited the same rate it is fair to all, and not so hard on the pocketbook. This would mean that everyone's contribution is equal, although a different amount, and myself and others at the lower end of the wage scale would not feel discriminated against.

P.S. To my recent understanding, Finance has been collecting time and a half in overtime to catch up on their work and <u>also</u> have received strike pay. Must be nice. Please tell the operating engineers to strike my building next!

Editor's Comment:

Firstly, thank you for your letter and valid criticism. It is through the membership's feedback where possible inequities can be dealt with, ideas considered, and direction of future policy initiated.

Secondly, although the \$1200 figure was not corrected, as it is possible in some instances, I'm sure a glance at our wage scale will indicate that this certainly does not reflect the majority salary (or close to it). A median was not available at time of printing.

And, as a final note - checking into the occurence of Finance employees and receipt of overtime, Cobie Wennes, our treasurer, tells me that many people in this situation have deducted amounts over their usual salary and returned it to the strike fund; either by personal cheque or another avenue.


