9. Executive Report

Ray Galbraith said that an Executive report will be given at each meeting in the future. Dues referendum is coming up by mail ballot. It will consist of three questions and first choices will be counted firstly but if no definite winner appears, second and third choices may be counted also to determine the "winner".

The situation regarding those people who crossed picket lines during the Operation Engineers strike is still pending. Those people with charges are to reconsider their position and report back to the Executive.

Maternity Leave - the legal decision was passed in our favour.

10. Contract Committee Report

Ray Galbraith reported on the various Division meetings that the Contract Committee had held. The wage demands ranged from 12-21% and there appeared to be a general lack of confidence in the whole area of job descriptions, particularly in the secretarial positions. There is a tentative meeting set up for November 29th at which contract proposals will be put before the membership for voting. AUCE's intent is to start negotiations with the University by mid-January.

11. Provincial Report

Richard Melanson gave the Provincial Report. There will be a Convention in February/March to discuss possible affiliation with the CLC. One charge has been dropped against the SFU "18" but attempts are being made to charge the people individually instead of as a group. This would weaken their position considerably.
