APPOINTMENT OF MEMBERS OF THE
INTERNATIONAL MILITARY TRIBUNAL FOR THE FAR EAST

1. In order to implement the Instrument of Surrender of Japan executed at Tokyo Bay, Japan, on 2 September 1945, and Paragraph 10 of the Potsdam Agreement of 26 July 1945, and in furtherance of Article 2 of the Charter of the International Military Tribunal for the Far East, the following nominees of their respective countries are hereby appointed as members of the International Military Tribunal for the Far East for the trial of such persons as may be properly brought before it:

The Honorable Sir William Flood Webb (Commonwealth of Australia)
The Honorable Mr. Justice E. Stuart McDougall (Dominion of Canada)
The Honorable Ju-As Mei (Republic of China)
The Honorable Mr. Henri Reimburger (Republic of France)
Professor Bernard Victor A. Roling (Kingdom of the Netherlands)
The Honorable Mr. Justice Erima Harvey Northcroft (Dominion of New Zealand)
The Honorable Mr. Justice I. M. Zaryanov (Union of Soviet Socialist Republics)
The Honorable Lord Patrick (United Kingdom)
The Honorable Mr. Justice John P. Higgins (United States of America)

2. The Honorable Sir William Flood Webb is designated as President of the International Military Tribunal for the Far East.

3. The Charter of the International Military Tribunal for the Far East (Article 1) provides that the permanent seat of the Tribunal is in Tokyo.

4. The responsibilities, powers and duties of the members of the Tribunal are set forth in the Charter thereof, published as General Orders No. 1 of this Headquarters, 19 January 1946.
