Die Firma Romain Talbot haette schon vor Jahren an diese Firmen herantreten muessen, denn teilweise gehen die Forderungen bis auf das Jahr 1932 zurueck.

Es erscheint hier aussichtslos, auf guetlichem Wege zu einer Zahlung zu gelangen. In Anbetracht der geringen Betraege, sowie da drei Firmen in dieser Angelegenheit verwickelt sind, kann zu einer Klage nicht geraten werden. Es darf gebeten werden, Ihre Bezirksfirma zu veranlassen, die hier entstandenen Kosten laut Anlage zu ueberweisen.

Dear Sir:

On Nov. 7, you wrote me concerning an account of mine with Romain Talbot.

As I remember it, this account was for a camera which I purchased through Mr. Ross Osborne of Toronto. It was sent to me direct from Germany prior to 1932. Immediately after clearing the camera from the Canadian Customs, I sent a money order to Romain Talbot.

I have had repeated demands for this money ever since that time. At one time, about 1933, they got in touch with my bank (at that time, Dominion Bank of Canada, Yonge and St. Clair Streets, Toronto) and had a draft against me issued. I showed my bank the money order receipt of payment, mentioned above, for the account, and they withdrew the draft.

In view of the unsettled condition of Germany since the advent of the present dictatorship, it is just possible that my little money order has been expropriated for state use without the knowledge of the unfortunate Romain Talbot Co. However, my bank was satisfied with the money order receipt that I presented, and that closed the matter as far as I am concerned.

I have been given to understand that the Germans are a persistent race of people, but I assure you that they will have to have a great deal more than this trait before I shall pay again an account that was closed many years ago.
