## Introduction

The National Association of Marine Engineers was formed during the 1880s. The earliest records in this collection are from the Vancouver local council #7 in 1902. The Association had numerous local councils spread across the country and often worked in concert with the Canadian Merchant Service Guild which acted on behalf of ship's masters and mates.

While the records cover the period from 1902 to 1966, the predominant material deals with the late 1940s through to the mid 1960s. During this time there was considerable internal rivalry between the eastern councils and the National Council as well as substantial raiding of members by other unions, particularly the S.I.U. in the east and the Canadian Brotherhood of Railway, Transport and General Workers in the west. In 1959 the Vancouver and Victoria councils decided to form a CBRT & GW local, Local 425 while retaining the Association. The dual nature of the marine engineers' union affiliation ended in 1966 when the members voted to combine with the Canadian Merchant Service Guild.

## Organization of collection

The papers of the National Association of Marine Engineers were deposited with the Special Collections Division as part of the materials of the Canadian Merchant Service Guild. They were arranged and described by Jim Burrows between January and May, 1985. The original order of the collection is outlined in a mini-inventory, a copy of which is attached to this inventory. For the most part, materials have been left in the original groupings. Some re-grouping

has been necessary for the sake of coherency.

The collection consists primarily of documents generated by the Victoria Local Council #6 and the Vancouver Local Council #7 which together made up District Council #4. However there is also a substantial amount of correspondence and financial material from the National Council executives. The bulk of the subject file papers were produced by the N.A. of M.E. Credit Union incorporated in 1952 and the CBRT & GW Local 425. While there was an attempt made to keep documents from the Association and the CBRT separate, there is naturally significant overlap.

In addition to reviewing the papers of this collection, researchers should examine the Canadian Merchant Service Guild collection which is also held by the Special Collections Division.
