The International Association of Bridge, Structural and Ornamental Iron Workers local chapter 712 is a shopmen's union, representing iron-workers in Vancouver, British Columbia. The chapter is a member of the Ironworkers District Council of Western Canada, and of the International Association of Bridge, Structural, Ornamental, and Reinforcing Iron Workers. Local 712 is a democratically operated union with elected officers and in-shop committees. The union's main functions include bargaining on behalf of members for collective agreements with employers, assistance and participation in pension and workers compensation programs, and access to legal council and job placement assistance.

Scope and content: The addendum to the fonds consists of various reports and ledgers kept predominantly by the financial secretary, Gordon J. Wick, of local 712. The reports include information on Union members, including member suspensions, membership dues, and new members initiated to the union. Also included in the accrual are check-off lists from the Dominion Bridge Company documenting the payment of workers' monthly dues.

Notes Area:

Physical condition: The majority of materials are in good condition. Some pages of reports are ripped, folded, or faded. Where possible, ledgers have been disassembled and reports have been placed in file folders for long term preservation.
