5. Treadurer's Report

A. Hutchinson, seconder

5(a) Provincial Report

- SFU strike was discussed at their last meeting. Lid Strand and R. Melanson moved a motion of support:

That AUCE Local I support AUCF Local II morally in its rights as a trade union to bargain collectively and in good faith; in its right to strike; and in its struggle to maintain the principles of democracy.

- Discussion L. Strand stated that SFU was offered 3% each year for the next 2 years; that they were under threat of an injunction from another union; and that they had a small strike fund.
 - N. Wiggs stated that (a) press printed story that AUCE Local II was not willing to go into binding arbitration. However, the Arbitrator would not be able to arbitrate as SFU Administration insists that he must take one or the other's position. Arbitration is not possible in such a situation.

(b) Should we support then financially?

- Jean Lawrence not keen on wording of motion.
- L. Strand stated that SFU is not covered by the Essential Services
 Act.
- J. Wright wanted to defeat this particular motion. Wording should be more specific.

R. Melanson moved that:

AUCE Local I conduct a referendum ballot to approve a \$5.00 assessment to replenish the Provincial Strike Fund.

C. Wiennes, seconder.

- Discussion C. Cameron asked if this assessment would take the place of giving SFU money.
 - N. Wiggs responded that the Provincial on the weekend had passed a motion and that they may not give this money to Local II. She suggested that the referendum be worded so that the money would go directly to SFU.
 - R. Melanson withdrew his motion.

Nancy Wiggs proposed a notice of motion

That AUCE Local I donate \$5,000.00 to AUCE Local II to support their strike.

AUCE Local I support her sister local, AUCE Local II and that a group of volunteers prepare a special bulletin to outline the history of the SFU conflict; to inform members of the provincial assessment coming up; and to inform members of the notice of motion to support AUCE Local II financially.

SPECIAL MEMBERSHIP MEETING MINUTES

MINUTES OF A.U.C.E. LOCAL I GENERAL MEMBERSHIP MEETING, MARCH 22, 1979

No official agenda, just Report of the Contract Committee, then question & answer period, motions resulting from the Contract Committee Report. Followed by other Business and motions.

CONTRACT COMMITTEE REPORT -- Ray Galbraith

1) History of negotiations to date as per Bulletin # 7.

- 2) Mediation session was held March 19-21
 - -- the Union Negotiating team managed to get rid of 12 University proposals over the course of negotiations
 - --during mediation the Union knocked off 21.01 and 34.04 University proposals
 - --33.06- the University agreed to Union proposal
 - --22.03- Hiring policy improved reading as per the Blue Contract
 - --University came up to 7% wage offer--the Contract Committee informed the Mediator that this did not meet with the terms the Committee was prepared to recommend to the Membership, but the Committee wouldn't speak against it either.
 - --Increment Policy, Longevity, and Union Meetings still on table-in limbo depending on outcome of motion to accept package. N.B. they can be brought up again next year.
 - --Committee believes not much moremoney available. Also, a Strike Vote might fail, therefore, not a good idea when it would adversely affect next set of negotiations--should be used when the wage offer is definitely below par.
 - --if the membership accepts motion on package, they vote to accept package by referendum
 - --if the membership rejects the motion, it means a vote to strike
 - --it would seem the University wants to settle, and therefore there has been no hasseling this year--they do not want to conduct 4 sets of negotiations at once.

QUESTIONS:

- 1) What does 7% mean? 7% to each step of each pay grade, a range of \$60-90 per step.
- 2) Is the Medical/Dental proposal still on table?—— Yes. If we reject the package the proposal is back on the table. The University wishes to set up a committee to investigate the possibilities.

 The Union Contract Committee would participate.
- 3) Comment that the Faculty is counting on at least 8% increase on staffing on research grant applications.
- 4) Could we go back to across the board? No, a breach of faith.

OPINIONS:

- 1) Lissett Nelson--wishy, washy offer, but to fight it we could end up like SFU. --at 7% we are loosing \$30/month as inflation is 10%.
 - --also with computerization we are more productive, and therefore are loosing still more money.
 - -- should strike and accept no less than 12%.
- 2) Nancy Wiggs--no more than 1% out there, though we could get maybe Union Meetings, etc.--We would have to take very firm action just to get that.
 - --we should take into consideration on top of the 7%, the proposals such as Employee Files that we have won.
- 3) Member--agreed and confirmed Nancy's opinion.
- 4) Neil Boucher--interest to the University on our retroactive pay.

- 5) Member--asked if term that University consider COLA be part of our agreement to package. Answer, no. University couldn't budget on one year --a strike issue.
 - --will have to be part of next negotiations.
- ----Contract Committee of the opinion that we can't get more non-monetary items, only could try by Strike to get more money.
- 6) Does the Strike Committee endorse acceptance?--no answer
- 7) Could we accept the 7% on proviso that the University accept some of our proposals? --No- the University's final offer.

DISCUSSION:

- 1) Nancy Wiggs--this motion if passed sends the acceptance to referendum.
- 2) Member--Could we take a strike vote to try to get a little more money?

 Ann--would have to go through all the steps of rejecting, etc.,

 If we reject the package we are back to square one on the other proposals also.
- 3) Member thought that the University had bargained in better faith this year so we should consider that.
- 4) Ray Galbraith--better in some respects but the University doesn't think much of our service--no respect--witness silly proposals and comments.
 --doesn't want to squander our Strike Vote and possibly fail or have a weak vote.
 - -- the University has shown more respect by starting with 5% this year.

- 3) Pat LaVac asked about base rates for SFU Local II--do they get more than us per month? --they get only \$958 over our \$938.
- 4) --also they are only offered 6% over 2 years, they only want 6% this year, 3% next year.
 - -- they have been on limited or no wages since end of December
 - -- they need a donation, not a loan
- 5) Sheila Perrett--\$22,000 in the hole now -only 6% on 1977 wages
